6. Discussion and presentation on best practices for diversion with Juvenile Probation Commission, at the request of the Commission (DISCUSSION)

Commissioner Yanez introduced line item. David Muhammed, Executive Director of the National Institute for Criminal Justice Reform (NICJR), presented and spoke about diversion programs. Commissioner Yanez introduced President Margaret Brodkin and the Juvenile Probation Commission attending the meeting.

Jessica Ellis, Executive Director of Centinela Youth Services and Everychild Restorative Justice Center, presented and spoke on community led diversion.

Juvenile Probation Department spoke and available for questioning.

# **Chief's Report**

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 4 percent; homicide up 27 percent; rape down 23 percent; robbery up 12 percent; assault down 1 percent; human trafficking down 44 percent. Property Crimes down 9 percent; burglary down 10 percent; motor vehicle theft up 2 percent; arson up 8 percent; larceny theft down 11 percent. Gun violence is down 3 percent compared to 2022; One shooting incidents this week; total 60 incidents resulting in 67 victims YTD. Two homicides for the week; there are a total of 19 homicides YTD with 13 resulting from a firearm; 194% overall clearance.

Significant Incident: Gun related homicide at 800 block of Eddy, 5/4/23 20:14, call of shooting received, Officers in the area responded, located 15 year old victim suffering from gun shot wound, witness reported a vehicle leaving at a high rate of speed immediately after hearing gunshots, private cameras located in area, footage showed incident and possible suspect vehicle, vehicle was spotted a short distance away, pursuit was initiated but terminated as it reached the city of Oakland, victim transported and succumbed to injuries, investigation ongoing. Shooting, 1500 block of Market, 5/5/23 16:08, victim in an argument with subject on bus, subject shot victim when they both exited the bus, suspect ran away, several witnesses provided statements and descriptions, victim transported, non-life threatening injuries, investigation ongoing. Body recovered at Pier 39 by Fire Department, victim not identified, Medical Examiner determining identification and cause, ongoing investigation. Shooting on Market Street at Walgreens, DA's Office taking a second look at investigation.

Significant arrest: Homicide on 400 block of Duboce, Park District, 5/5/23 11:00, Officers responded to a call of possibly deceased person in stairwell at location, video from building showed victim walking in stairwell and stumble, falling to where she was located by Officers, later determined victim suffered stab wound and succumbed to injuries, while on scene Officers received information that identified a suspect, located in same building, probable cause, suspect arrested and booked for homicide and elder abuse. Arrest in series of 9 bank robberies 4/26-5/9/23, Citibank robbery, Richmond District Officers located and arrested suspect. 3/30/23 a victim shot in back in area of Willow Ave and Van Ness, during investigation possible suspect identified, believed to be narcotics dealer who frequents area of 700 block of Eddy Street, 4/29/23 probable cause established to arrest suspect, evidence linked suspect to shooting.

Strategies: Stunt driving, no events over the weekend. Last two weeks, after investigation, seized three vehicles.

Report on recent DPA activities, and announcement

Chief of Staff, Sarah Hawkins, on behalf of Executive Director Henderson reported the following: In the year 2023: 266 cases opened; 279 closed; 268 pending; 24 cases sustained; 26 cases past 270-day; 6 cases mediated. Cases received in the past week: 14 new cases; -Southern (1) Improperly citing and towing a vehicle. Bayview (2) Writing an inaccurate police report and acting with racial bias. Failing to investigate a stolen vehicle. Mission (3) Behaving inappropriately, providing inaccurate translation, and failing to activate BWC. Richmond (2) Harassing a person and failing to investigate a vehicle theft properly. Ingleside (3) Failing to properly investigate an auto burglary and citing the wrong person for a battery. Not Applicable (3) Referral. Failing to properly refer a crime for prosecution.

Audits: DPA issued their next key issue report on SFPD's handling of Officers' discipline, available on DPA's website. Tentatively scheduled to present this report on June 7<sup>th</sup>. DPA won an award, audit team of two will present report and receive award.

Outstanding Issues: Timeclock for DPA investigations, completed within a year, goal to complete within 270 days. 7 cases pending with Police Commission, 82 cases pending with Chief.
