## 3. Consent Agenda

a. Approving the Minutes of the October 21, 2021 Meeting

Director Richardson moved Item 3. Director Tsen seconded the motion. Item 3 was passed unanimously by roll call vote.

## 4. 2021 Biodiversity Survey of YBI Presentation by California Academy of Sciences

Alison Young and Dr. Rebecca Johnson, California Academy of Sciences, presented their Yerba Buena Island intertidal and eelgrass survey.

Study objectives were to survey the biodiversity of YBI intertidal areas to develop species lists, to survey Treasure Island marina fouling community to develop a species list, to understand which intertidal habitats harbor the most native diversity, to survey for eelgrass along the southern edge of Clipper Cove and to situate the YBI intertidal in the context of San Francisco Bay. Ms. Young reviewed the eelgrass survey sites.

Ms. Johnson reviewed the methods for intertidal survey, eelgrass surveys, and species documentation.

Ms. Young reviewed the species documented in Yerba Buena Island intertidal biodiversity study. Seven species have never before been documented in San Francisco Bay.

Ms. Johnson presented recommendations including rocky points, using interpretive signage, and to continue eelgrass surveys and bioblitzes.

Director Tsen commented on the inaturalist app, importance of outreach to youth and island residents, and asked about importance of eelgrass.

Director Richardson commented on sustainability and educational opportunities.

## 5. Five-Year Sea-Level Rise Findings Presentation by Moffatt & Nichol

Dilip Trivedi, Moffatt & Nichol, presented the Sea Level Rise Risk Assessment and Adaption Strategy for Rising Sea Levels.

Mr. Trivedi reviewed water level data, sea level rise trends in SF Bay Area, flood events at TI (there have been none), SLR projections, and the TI adaptation strategy.

Director Richardson asked about BCDC data request and where to find information. Director Dunlop asked about potential of liquefaction during earthquake. Director Tsen commented on SLR mitigation strategies for TI buildings.

There was no public comment.

## 6. Legacy Household Ranking for the Transition Unit Offers

Bob Beck, TIDA, presented the transition benefits for legacy households. Transition benefits include offer of transition unit, advisory assistance, moving payment, and premarketing notice.

The lottery will take place on May 5<sup>th</sup> in partnership with MOHCD.

There is no action or decision required of households before or immediately after the ranking occurs.

The first transition units will be ready for occupancy in 2024.

Mr. Beck reviewed prioritized ranking for legacy households.

Karen Eddelman, ARWS, reviewed outreach and follow up to the 270 legacy residents.

Ms. Eddelman reviewed documents available on TI Advisor Portal and the legacy household ranking schedule.

Director Dunlop asked if residents attending ranking in person made a difference. Director Richardson asked about records of follow up with legacy residents.
