ORDER OF BUSINESS

1. Call to Order 1:00pm

2. General Public Comment

There was no public comment.

3. Update on Development Project Revegetation and Tree Planting Activities on Yerba Buena Island

Greg Barger, CMG, gave an update on revegetation and tree planting on YBI.

YBI Stormwater gardens will be complete August 2022.

100% of the stormwater that falls on the vertical and horizontal development areas will be captured and treated.

Planting includes 195 new trees and over 60 species of native plants.

The Rocks Dog Park will be completed August 2022.

Construction included use of salvaged stone and wood from the island.

Planting palette includes native coastal scrub plants and several oak trees.

Water Tanks will be complete fall 2022.

Planting includes 90 new trees, native coastal scrub, and oak woodland plants.

TI SIP Phase 1 will be completed November 2022.

Planting includes over 250 new street trees.

Mr. Barger reviewed parks to be completed in 2023 including TI Waterfront Plaza, Signal Point, Clipper Cove Park, Infinity Point, YBI Trails, TI Cityside Park Phase 1, and TI Cultural Park.

Director Tsen commented on buckeye trees and asked about maintenance plan for native gardens and cleaning of dog park.

Director Richardson commented on longevity of parks and maintenance of parks.

Director Tsen asked about the replanting of palm trees.

4. Update on Yerba Buena Island Native Plant Demonstration Gardens on Treasure Island

Peter Summerville, TIDA, presented on YBI native plant demonstration gardens.

Since 2019, 8 gardens have been installed adjacent to on-Island community serving facilities and Island businesses.

Parks were installed by Rubicon Landscape utilizing plant stock from on-Island native plant nursery operated by Literacy for Environmental Justice.

Gardens contain an assortment of species intended to showcase the diversity of YBI's native flora.

Species for individual sites are chosen based on site conditions including exposure, orientation and on-Island location.

Rubicon Landscape maintains the sites under the Master Agreement for Landscape Services.

Mr. Summerville reviewed gardens at the Ship Shape Community Center, TI Gym, TI Playground, Life Learning Academy, 9th Street parking lot, and TI tennis courts/DIY skate park.

Director Tsen commented on opportunity for Mediterranean palette on TI.

Director Richardson asked about plan for gardens when development begins and commented on engagement with SFUSD.

6. Discussion of Future Agenda Items by Directors

Director Tsen requested an update on recreational plan and asked about including a pickle ball court on TI.
