**HEALTH COMMISSION COMMUNITY AND PUBLIC HEALTH COMMITTEE MEETING**

Members of the Health Commission Community and Public Health Committee will attend this meeting in-person. Members of the public are invited to observe the meeting in-person or remotely online using this link: <https://sfpublic.webex.com/sfpublic/j.php?MTID=m40c6e27a5da6b237acb324b556db0918>.. Everyone attending the meeting in person is encouraged to wear a mask throughout the meeting.

Public comment is allowed in relation to each agenda item, and the Secretary of the Health Commission will indicate when public comment is to occur for each item when not listed on the agenda below. Each member of the public, whether attending remotely or in person, may address the Commission for up to three minutes. Members of the public attending the meeting in person will have an opportunity to provide public comment on every item. In addition to in-person public comment, the Health Commission Community and Public Health Committee will hear up to 20 minutes of remote public comment on each agenda item. The Health Commission will hear remote public comment on each item in the order that commenters add themselves to the queue to comment on the item. Because of the 20-minute time limit, it is possible that not every person in the queue will have an opportunity to provide remote public comment. Requests to include a maximum of 150 word written public comment in the meeting minutes can be made at [healthcommission.dph@sfdph.org](mailto:healthcommission.dph@sfdph.org). Remote public comment from people who have received an accommodation due to disability, as explained on page 3, will not count toward the 20-minute limit. Instructions for providing remote public comment can be viewed on page 5 of this meeting agenda.

Committees of the Health Commission consist of three members of the Commission. If a quorum of the Health Commission is present, it constitutes a Special Meeting of the Commission. If additional commissioners attend the meeting of a committee creating a quorum of the full Health Commission, they may participate in the discussion on an item on the agenda but may not vote with the members of the committee. The committee's recommendations shall be reported to the full Health Commission for discussion and possible action. The Health Commission Secretary shall make a note of the presence of the additional commissioners in the minutes, and discussion shall be limited to items noticed on this agenda.

1) **CALL TO ORDER**

**RAMAYTUSH OHOLONE LAND ACKNOWLEDGEMENT**

The San Francisco Health Commission acknowledges that we are on the unceded ancestral homeland of the Ramaytush (rah-my-toosh) Ohlone (O-lon-ee) who are the original inhabitants of the San Francisco Peninsula. As the Indigenous stewards of this land, and in accordance with their traditions, the Ramaytush Ohlone have never ceded, lost, nor forgotten their responsibilities as the caretakers of this place, as well as for all peoples who reside in their traditional territory. As guests, we recognize that we benefit from living and working on their traditional homeland. We wish to pay our respects by acknowledging the Ancestors, Elders, and Relatives of the Ramaytush Ohlone community and by affirming their sovereign rights as First Peoples.

3) **FOR ACTION:** **REVISIONS TO HEALTH CODE ARTICLE 31 REGULATIONS.**

San Francisco Health Code Article 31 and the Article 31 Regulations set out a process for review of City permits that involve earth disturbing activities on transferred parcels from the former Hunters Point Shipyard (HPS). Article 31 and the Article 31 Regulations are designed to ensure that hazardous materials mitigation measures and environmental restrictions, placed on the property, are implemented. The committee is not being asked to consider changes to the San Francisco Health Code Article 31 at this time and is only being asked to consider amendments to the existing Article 31 Regulations. The committee will review revisions to Article 31 Regulations and will consider recommending them for full Health Commission approval. Approval is requested.

4) **FOR DISCUSSION:** **HEALTH CODE ARTICLE 38, ENHANCED VENTILATION RULES AND REGULATIONS**

San Francisco Health Code Article 38 establishes air pollutant exposure zone criteria to create a citywide Air Pollution Exposure Zone Map (APEZ) which is updated every 5 years. The Commission will review the updated APEZ criteria and enhanced ventilation proposal and design submittal and maintenance requirements for Health Code Article 38, Enhanced Ventilation Rules and Regulations.

5) **FOR DISCUSSION:** **JAIL HEALTH SERVICES UPDATE**

### **Information Regarding Providing Public Comment**

- Each individual may comment 1 time per agenda item.
- Each individual may speak for up to 3 minutes; after which time the line is automatically silenced.
- To make public comment on a specific agenda item, dial in using the information above, when the item is called.
- Dial “\*3” to be added to the public comment queue for this item.
- When it is your time to speak, you will hear “Your line has been unmuted.”
- Ensure you are in a quiet location.
