The mural has four coats of anti-graffiti sheer coat (purchased from Precita Eyes Mural) which will protect from graffiti. The owner of Papa Maks is responsible for maintaining the mural / removing graffiti should it get tagged.

## **ARTIST AGREEMENT**







Art@Work is a program created by Supervisor Gordon Mar's Office in collaboration with the Office of Economic and Workforce Development, Self-Help for the Elderly & Sunset Mercantile. The program will connect small businesses in the Sunset with local artists to beautify and enhance storefronts. Artists will receive a stipend of \$2,000 (in two installments) and must live in District 4.

By accepting this agreement, participating artists agree to the following: (initial each line)

- <u>NC</u> Submit all necessary documentation to Art@Work before the project starts (application, artist agreement, approved art design & timeframe agreement)
  - Work with the Art@Work team and business owner to design the project
  - Provide the business owner with a sketch & description of the proposed art project before executing the installation
  - Agree that both the business owner and the artist will sign documentation approving the design & art installation, as well as the timeline, before the project begins
- Med Agree to work with business owner to execute installation while taking into account the business' daily operations / timing preferences
- $M_{c}$  Agree that the business owner will display the artwork for at least 6 months
- Agree that the business owner can decide to make the art installation permanent
- $\mathcal{O}_{\mathcal{O}}$  Agree that the artist owns the artwork's design/copyright
- Agree that the project budget of \$2,000 will be paid to the artist (and will not exceed \$2,000 unless the business owner agrees in writing to cover additional costs).
- Agree to communicate directly to the Art@Work team with any requests, concerns or complaints.
