## **DPA Director's Report**

Report on recent DPA activities, and announcement

Executive Director Henderson, reported the following: In the year 2023: 326 cases opened; 344 closed; 261 pending; 28 cases sustained; 22 cases past 270-day; 14 cases mediated. Cases received in the past week: 12 new cases; Central, 1, Officers took too long to respond to a reported stabbing. Southern, 2, Officers failed to investigate a report of a stolen van. Officers failed to notify a security guard of their operation, placing the guard in danger. Bayview, 1, The complaint witnessed a person in distress and called 911 for help. The officers' response was poor and delayed. Mission, 2, The officer conducted a traffic stop on the complainant. During the stop, the officer made inappropriate comments and acted aggressively toward the complainant. The officer also failed to call a supervisor to the scene. Officers detained a person for a mental health hold

without cause and used unnecessary force, causing injury. Park, 1, The complainant alleges that the officers behaved and spoke to them inappropriately. Ingleside, 2, The officers used excessive force on the complainant. Officers failed to contact the complainant when responding to her call for service. Tenderloin, 1, Officers failed to investigate the theft of property properly. Additionally, a district station refused to accept the complainant's request to speak to a superior officer. Not applicable, 1, Referral. Out of Town, 1, The officer harassed the complainant during his last arrest by making comments and having his car sold off after being seized.

Audits: Reviewed SFPD's 30-month responses to DPA's Use of Force Audit, a presentation forthcoming.

Director of Recruitment, Tinnetta Thompson, Attorney, introduced DPA's largest summer law and justice cohort. Over 25 people, representing 9 colleges and 4 law schools. Including the first HBCU cohort, intentionally recruiting from Howard University and Morehouse College. Other city agencies are also working with these interns.

## **Chief's Report**

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 4 percent; homicide up 10 percent; rape down 22 percent; robbery up 15 percent; assault down 3 percent; human trafficking down 40 percent. Property Crimes down 8 percent; burglary down 11 percent; motor vehicle theft up 5 percent; arson up 6 percent; larceny theft down 10 percent. Gun violence is up 5 percent compared to 2022; three shooting incidents this week; total 82 incidents resulting in 100 victims YTD. One homicide for the week; there are a total of 22 homicides YTD with 15 resulting from a firearm; 91% overall clearance.

Significant Incident: Shooting in Mission District, 9 individuals shot, no deaths, progress on case, not connected to any other incidents. Shooting in Ingleside District, 3 individuals shot at a nightclub, independent of any other incidents. One person shot and killed in Tenderloin. Sixteen people total shot in reporting period, one did not survive. Turk Street homicide, 01:37, no suspect in custody, investigation ongoing. Stunt driving events, response teams rallied resources to break up events, cars made it to bridge, headed east, one citation, in general impounded a total of 75 cars for stunt driving after the fact.

Significant arrest: From a June 5<sup>th</sup> incident, victim was being followed by an unknown male shouting anti LGBTQI+ hate slurs, suspect threw object at victim, during investigation suspect was identified, located and arrested.

Strategies: Tenderloin, YTD recovered/seized 61,449 grams of Fentanyl (this time last year was 23,801 gross grams of Fentanyl)

Commissioner Walker: Working with department on status of women being recruited, partnering with neighborhood groups, events and reaching out. On going discussions regarding Patrol Specials and opportunities in the private sector. Agendize Patrol Specials in September.

Commissioner Yee: Visited the new crime lab. DGO 6.14, spoke with DPA and SFPD Members. President Elias: Acknowledged and provided historical information on Juneteenth.
