Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 3 percent; homicide up 10 percent; rape down 22 percent; robbery up 13 percent; assault down 3 percent; human trafficking down 40 percent. Property Crimes down 6 percent; burglary down 10 percent; motor vehicle theft up 6 percent; arson up 5 percent; larceny theft down 8 percent. Gun violence is up 11 percent compared to 2022; Four shooting incidents this week; total 86 incidents resulting in 105 victims YTD. One homicide for the week; there are a total of 23 homicides YTD with 16 resulting from a firearm; 91% overall clearance.

Significant Incident: Pier 39 area shooting, 18:49 6/18/23, car to car shooting between occupants of both vehicles, victims injured, incident started at Stockton and Beech traveled toward Pier 39, south on Embarcadero and ended at Howard, 4 people injured, two individuals transported are to believed to be involved, one subject booked under a warrant, investigation open and ongoing. Shooting in Tenderloin, Turk Street, 6/13/23 01:37, resulted in death, Officers responded to a shooting, found victim lying on sidewalk, Officers rendered aid, victim transported to hospital, succumbed to injuries, no arrests made, investigation ongoing. Four shooting incidents this week, four victims and two unknown victims. Shooting 500 block of Turk, numerous subjects involved in altercation, victim stabbed, victim left scene and collapsed on 200 block of Leavenworth, 2nd victim shot on 500 block of Ellis, witnesses flagged down Tenderloin patrol unit who summoned an ambulance, call for stabbing victim received after and located that victim, investigation ongoing, no arrests. McAllister and Hyde, 6/14/23 23:35, Officers responded to SFGH for a self-transported gunshot victim, driver detained and interviewed by Sheriffs, location of shooting not determined, investigation ongoing, no arrests. Polk and Post, 03:38 6/17/23, Officers responded to several calls for shots fired, callers reported two victims lying in street with possible gunshot wounds, Officers did not locate any victims on scene, search of local hospitals was negative, did not verify anyone shot from incident, did recover multiple rounds from scene and located several witnesses, investigation ongoing.

Significant arrest: Aggravated assault, hate crime, commercial robbery, occurred 6/10/23 17:55, 1200 block of Thomas, Towing business, two subjects entered and confronted two victims- owner and customer in the middle of a transaction, subjects ordered victims to ground at gunpoint and kicked victims multiple times, subjects grabbed money from counter and fled from scene in two different vehicles, Officers attempted to stop both vehicles, Officers located one vehicle which was abandoned, witnesses directed Officers to one subject who had changed clothing, Officers located items used during robbery inside vehicle, one subject and one vehicle remain outstanding, investigation ongoing.

Strategies: Tenderloin – Officers seized 341 grams of Fentanyl (YTD seized 61,790 grams of Fentanylincrease of 159% compared to 2022). Narcotics seized YTD 95,426 grams (148% increase from 2022). Arrests for possession of sales, 390 arrests. Effort to curb street usage, 62 arrests, 4 people have identified as being from San Francisco. CHP released statistics – 92 total arrests.

Paulette Brown: Spoke about an article published on 10/19/22 regarding homicide reward money. Asked for department to hire someone to work on reward money or payment for tipsters. It has been 17 years since the murder of her son.

DPA Director's Report

Report on recent DPA activities, and announcement

Executive Director Henderson reported the following: In the year 2023: 346 cases opened; 366 closed; 265 pending; 29 cases sustained; 21 cases past 270-day; 14 cases mediated. Cases received in the past week: 19 new cases; - Central 3- The officer would not allow to speak with a supervisor, lied about information, referred to file the report request online and classified her issues as a civil matter. An officer failed to display a front license plate on their personal vehicle. Southern 1- The complainant alleges that the officer was rude at the police station. Bayview 2- the complainant stated that he was fixing his car earlier at a handicapped parking spot but was issued a citation later when his car was parked on the street. Mission 2- Officers detained the complainant for a mental health hold without cause and used unnecessary force causing injury. Northern 2 - The officer failed to arrest the complainant's property manager who entered her home and replaced her shower head and set up cameras multiple times. Advised of up to a six-hour delay for officers to respond to a low priority call. Park 3- An officer did not make an arrest, filed an inaccurate report and sided with the other person involved. Officers failed to address the complainant's call for service regarding a violation of a restraining order and improperly sided with the alleged violator. Richmond 1- The complainant stated that officers failed to take a report and rushed him out of the station. Ingleside 2- The complainant stated that officers failed to take a report and rushed him out of the station. Tenderloin 1- Officers failed to confirm service of TRO and released perpetrator. Not Applicable 1- The officer made a stop without cause, used excessive force, and foul language towards the complainant. Another officer used unnecessary force against the complainant's partner. Pending 1.
