ARTIST BIO

ChiChai (she/her) is a multi-disciplinary artist, educator, and community-gatherer born and raised in Occupied Ohlone Land, also known as the Bay Area. Whether teaching or creating, ChiChai's work is intersectional in its roots to nature, feminism, and the dismantling of colonial mindsets. You can catch her teaching art and how to use art as a tool for decolonizing to youth and adults.

ChiChai received her MA in International Studies from University of San Francisco (2016), in which she was awarded Most Original Thesis for her master's thesis "Challenging Filipino Colonial Mentality through Philippine Art." She has taught youth for various nonprofits throughout the Bay Area, including Destiny Arts, Galing Bata, and Youth Art Exchange.

BAHAY at BUHAY (2022)

DESCRIPTION

"Bahay at Buhay" - meaning "home and life" in Tagalog - features a woven tapestry of Philippineinspired patterns (from landscapes to fruit and fauna) and space for community members of SoMa Pilipinas to write offerings to the city.


Among these vibrant and abstract images are three precolonial Tagalog goddesses in each section of the mural: Diyan Masalanta, Hanan, and Lakapati.

Community organizations invited to write their offerings include: Galing Bata, SoMa Child Care Inc, Balay Kreative, Youth Art Exchange, and Pin@y Educational Partnerships.

SHARING THE HARVEST (2021)

- 700 sq ft acrylic latex mural
- Located at Kain Na Community Food Hub by Tenderloin Neighborhood Development Corporation
- Commissioned by Building 180

DESCRIPTION

I attended focus groups of the TNDC's community members for research in designing the mural. Key points they wanted in the mural are culturally relevant healthy foods and the joy found in sharing food with one another.

In honor of the new food community hub being named Kain Na, precolonial Tagalog Goddess Lakapati — the goddess of harvest — peeks through San Francisco's hills. She is featured granting the land to be bountiful and its people fed. Black oak acorns — an Ohlone delicacy — beam out her hands as other fruits and flowers grow on her hill, joining in with the community's sharing of harvest. PAST WORK

Woven in the landscape are community members blooming with fresh foods from their cultures. The families featured share delicacies from their cultures with each other.

SELECT PIECES FROM SOLO SHOW AT SOMARTS REROOT (2023)



DESCRIPTION

Utilizing self-portraits with Philippine-inspired fashion design, this series of mixed media work discusses the similar search for things to root to, comin from the #filipinx diaspora and from an estranged family history.

How do we root ourselves when being raised away from the motherland? Are there ancestors to root with when unrooted from our own living family? What and who do we find home in to be grounded in + bloom with?

DESCRIPTION

SOMA

This mural is dedicated to the past, present, and future Filipinx making a home for us here in SoMa. Woven in this karabaw diwata (fairy) are community members of SoMa and different landmarks.

A mural for the community couldn't have been done without the community. I had the honor of meeting with activists and artists for their guidance in creating this mural.



MALAYA 72" x 48" acrylic mural Located at Kapwa Gardens Commissioned by Kultivate Labs

DESCRIPTION

The word "malaya," meaning free in Tagalog, exemplifies the process of this piece.

This is the result of freestyling with guidance from my own spirit and a call to ancestors.

A diwata in a power pose

appeared. She's made of some of my favorite things and landscapes that I miss and love in the Philippines, such as limestone mountains in Rizal, bright turquoise waves, wild sunflowers blanketing Baguio's mountains, and the precolonial and revival of gold adornment.





CARE FOR MOTHER EARTH (2022)

DESCRIPTION

The background is inspired by woven Ohlone baskets. Rising across it are two caring hands transforming into native florals and fauna. To further express the richness of our ecosystem when there's mutual care between us and the earth, there are butterflies flying towards this nature transformation.

Mural Maintenance Plan

SOMA West Community Benefit District (SWCBD) agrees to make a good faith effort to maintain the murals for at least ten (10) years from the date of this Agreement. In the event that SWCBD determines that the murals are deteriorating or peeling, or in the event of casualty or condemnation to the Property, SWCBD and the property owners may elect to remove the murals, in its sole and absolute discretion.


- a. Anti-graffiti coating and UV Protection such as MuralShield or CleverClean will be applied to the wall upon the mural's completion. This coating will help protect the artwork against graffiti and UV damage. When the mural is tagged, a solution will be applied to the paint in order to remove it safely by SWCB Staff.
- b. SWCBD agrees to notify the Artist of the need for any maintenance or restoration within five (5) years of the date of this Agreement, so that the Artist may have an opportunity to perform or supervise such work. The Artist shall be reasonably

compensated by SWCBD for this work pursuant to a separate agreement.

c. SWCBD shall make reasonable efforts to notify the Artist if the murals become materially damaged or if the Property is sold.

PAGSASAMA SAMA (Tagalog for" joining together") celebrates SOMA Pilipinas' legacy of community members coming together. We interweave like the solihiya rattan pattern, creating bursts of sun and breathing life into the neighborhood.

Central to the Folsom façade are two diwatas formed by waves— the waves of the sea that connect the Philippine islands, waves of the Pacific that connect the SF diaspora to the Philippines, and the waves we make here in SOMA herself. These waves weave all the figures together, including the diwatas' hands reaching out to one another as the Philippine sun shines through.

Such as the use of waves, I was also inspired by Franceska Gamez's Pagmamana nod to Philippines wood-relief carving. Like how Filipinx craftsmen use the carvings for storytelling, these painted "wood carvings" show stories of our bayanihan's kultura, intergenerational support, performances and creativity, activism, resistance, and joy. If selected, I would do outreach to the neighborhood's organizations for input on Pinays/Pinxys to include for these "wood-carving" figures.

The Russ St. side would be used to further storytell with the waves, wood-carving illustrations and the solihiya pattern. The waves and solihiya pattern would be continuous from the Folsom side. In the middle is baybayin for "makibaka," which was used in SOMA's former street banners to represent "community." Makibaka is also an important phrase for the Filipinx fights for social justice; for example, the organization MAKIBAKA (1970's) is considered the first feministorganizations in the Philippines.

The overall goal of this proposal is for the neighborhood to feel connected to the mural and proud to see Pinay/Pinxy wave-makers that they may personally know or have been inspired by.

As a condition of the Property Owner's approval and authorization to create the Artwork on the Property, Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Artwork and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989)("CAPA"), or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights (collectively "Moral Rights Laws"), with respect to the Artwork, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the Property Owner or any future owner of the Property. If the Artwork is incorporated into a building such that the Artwork cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Artwork, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the Property, and its agents, officers and employees, for Modification of the Artwork.

The Property Owner, or any future owner of the Property, has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Artwork, in whole or in part without prior notice to the Artist. However, if the Property Owner, or any future owner of the Property, modifies the Artwork without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Artwork in accordance with 17 U.S.C. § 106A (a) (2).

The Property Owner has no obligation to pursue claims against third parties for modifications or damage to the Artwork done without the Property Owner's authorization. However, the Property Owner may pursue claims against third parties for modifications or damage or to restore the Artwork if the Artwork has been modified without the Property Owner's or Artist's authorization. In the event that the Property Owner pursues such a claim, Property Owner shall notify the Artist, and Artist shall cooperate with the Property Owner's efforts to prosecute such claims.

Artist bears the sole responsibility for providing the San Francisco Arts Commission and Property Owner with any changes to the Artist's Address for Notice.
