Dear Police Commission,

I'm a San Francisco resident who sees the fentanyl-fueled drug epidemic as the main issue our elected leaders need to solve. This crisis is linked to all of the problems San Francisco faces, including homelessness, mental health, public safety, and economic vitality. You must make ending open-air drug markets and funding more city-sponsored recovery programs the main priorities of this year's budget.

It's encouraging to see elected officials at the local, state, and federal level call for coordination to close drug markets in San Francisco. To ensure these calls for action are effective, there must be a senior official appointed by the Mayor who is responsible for and empowered to bring all necessary resources together to permanently disrupt drug markets. I look forward to seeing a robust strategy and plan to disrupt drug dealing in our community.

The Board of Supervisors must ensure that Mayor Breed's public safety investments remain in the final budget. The proposed budget funds our community's law enforcement requests, and I'm grateful for the Mayor's responsiveness to our community's calls for action. Funding to meet the recommended number of sworn SFPD officers, adding staffing aides to allow officers to answer high-priority calls, and investment in personnel training and narcotics equipment will make a real difference in law enforcement's efforts to close San Francisco's open-air drug markets.

The Mayor and Board of Supervisors must ensure the budget reflects an investment in closing the gaps San Francisco has for delivering true treatment on demand for recovery services. Mayor Breed's proposed budget funds a number of our community's demands, like expanding completely drug-free therapeutic teaching communities for justice involved people, expanding the capacity of the Billie Holiday Center to serve more justice involved people, funding 50 new dual diagnosis treatment beds, and making it easier for recovery service providers to offer competitive jobs.

But true treatment on demand enables people to recover from substance use disorder. This means that anyone who wants treatment gets it immediately, with no one forced to wait on the street or in jail. San Francisco needs to deliver a continuum of care, from harm reduction as the baseline to full recovery as the goal—I'm not confident that the proposed budget investments make the right choices to fully close the current gaps.

Funding must be provided to bolster intake center capacity. The current system for getting those who request treatment into recovery programs is a patchwork of hotlines and street response teams that result in people waiting for days. While it's encouraging to see that there's a new stabilization center planned for 2024, it must have enough beds and a guarantee that people can enter it once they request treatment, then efficiently directed to the appropriate in-patient treatment program. We also need more significant investments in in-patient treatment programs that have recovery as the goal.

Finally, I'm concerned that spending \$18.9 million in opioid settlement funds for three Wellness Hubs isn't the best use of this money, as Wellness Hubs are intended to provide overdose prevention, overdose reversals, and safe consumption sites. Overdose prevention and reversals are critical, but other city services already offer these more efficiently. This money should be directed to services like SoMa RISE that will help people get healthy and sheltered—sober hotels, intake centers, and more drug treatment beds.

Again, I'm grateful to Mayor London Breed for taking steps to end San Francisco's drug crisis with this proposed

budget. I know completely eradicating drug use is unrealistic. But City Hall has the opportunity to improve the lives of all San Franciscans by slowing the rate of overdoses as well as reducing the open-air drug sales and drug use that are eroding our city. Ensure this happens by fully funding these priorities in the next budget.



Public Comment for the August 29, 2023 Stop Data Analysis Subcommittee Meeting

These comments straddle subcommittees and meetings, past and future. What I write today, is primarily meant for the August 29, 2023 Stop Data Analysis Subcommittee Meeting.

It escapes me how Stop Data Analysis can be worth more than a bucket of warm spit if the data is adulterated, quite often deliberately so; something doubtless known to the RIPA Board, especially since I have always told it so.

It is more than uncanny that my communication, in the thread, concerning the SDPD, shown below, sent On Tue, Aug 22, 2023 at 9:18 PM Richard Hylton <a href="mailto: hyltonrichard@gmail.com wrote: is practically identical in meaning to what was confirmed, by the Mayor and police brass of LAPD, on Thursday, August 24, 2023, and elaborated upon in the last several hours. In essence, large numbers of detentions and traffic stops, made by the LAPD, were not documented and, by implication, not LAPD-reported or RIPA-reported. None should be shocked or surprised.



In the LAPD release, Chief Michel Moore said "the Department's expectations are that all traffic stops or detentions will be fully documented, and body-worn video devices will be used as required. "Consequences for any member who would purposely avoid our requirements will be certain and severe," Moore said. "Such misconduct undermines the public's trust and tarnishes the badge of the vast majority of officers who conduct themselves with integrity and reverence for the law."

I put it to you that it is more likely than not that the enormous reductions that we saw and continue to see in **reported** LAPD stop activity is more akin to what happened in the LASO jurisdictions, and in the SDPD, than in keeping with and nonsense that spews out of anyone, anywhere, going forward. As I have repeated, ad nauseam, for around two years -certainly more than one- I found massive unexplained anomalous data changes, in many places including the foregoing LEAs (LAPD, LASO, SDPD) the SFPD and SDSO and two fistfulls of others. As has been demonstrated and confirmed in the LAPD, and as shall have been demonstrated, for the SDPD, a connection exists between greatly reduced **reported** stops and unrecorded BWC interactions.

All that I put to you today, I have repeatedly put to the Sad Diego City Auditor and his colleagues. over the course of several months, with respect to the 243,000 body-camera-recording- worthy incidents that were not recorded a few years ago. I have confirmed that fewer than 3,000 of the 243,000 were RIPA-reported. I do not know or have not determined now many should have been RIPA-reported, because the City Auditora and others, in the employ of the City of San Diego, have made that determination difficult, not impossible.

In any comment, or communication, regarding these things, one may seem remiss by not mentioning Oakland. I am not being remiss, it is just that I do not bother to deal with Oakland's results anymore, because all that is related to **data** that oozes out of Oakland seems false. Oakland's posture regarding the handling of Civilian Complaints does not seem false, they merely seem engineered so that failure in timely handling and resolution is guaranteed.

I shall have more to say about this later.

The woman thrown to the ground by a Los Angeles County sheriff's deputy outside a grocery store in Lancaster was due in court Tuesday. Robbery **suspect**

Jacy Houseton had been charged with resisting an executive officer. But according to her attorney, Caree Harper, the cases against her and fellow **suspect** Damon Barnes were dismissed. We reached out to the district attorney's office but have not heard back.

The most rudimentary EIS could have seen this coming, I did, see it coming. The SDPD had been in the habit of manufacturing crime rates for Black areas, until Myrtle Cole asked unanswerable questions, and may have put a stop to the practice. Some local news outlets are still busy at vilification, although not **night after night**; but some through the use of race-inspired or stilted vocabularies.

I have nothing much to add, other than that my former comment on the impugning of entire races, using such tactics, as used by Nixon and the SDPD, has a rich history in America. The above passage on Narcotics Enforcement is brought to us, through the courtesy of the RIPA Advisory Board. I had planned to complain about the SDPD, its folly and unmanaged madness in the Civilian Complaint Subcommittee meeting that is scheduled for Wednesday, only to learn that this matter that impinges rather heavily on Data-Analysis, may be better suited for next week's Data-analysis Committee Meeting. Perhaps, I will just compain twice. Old people are forgiven for doing such things.

The 2024 Draft RIPA Report contains a section that indirectly addresses your former venture. By your former venture, I mean that sham of an exercise that saw your group identify 243,000 instances of officers being dispatched, but which venture outrageously, curiously and unbelievably, did not include which person's interactions went unrecorded. By which person I mean the race or ethnicity of the unfortunates whose encounters were denied preservation.

Then came the California Department of Justice, masters of indirection, with

this proposed content for the 2024 RIPA Report:

Resisting Arrest Examining the result of stop where someone is charged with resisting arrest and no other underlying violation may be an indicator of a pretext stop because the individual does not receive a citation for the original reason for stop, such as a broken tail light. This stop outcome is also important to review because it is often linked to use of force incidents. The U.S. DOJ conducted several investigations of law enforcement departments and specifically examined resisting arrest charges.86 DOJ found racial disparities in who was alleged to be resisting arrest. Data also showed that in these incidents, there was likely no evidence to stop the person in the first place, since they were not arrested or ticketed for the underlying basis for the stop.87 In California, resisting arrest can be charged as a misdemeanor or a felony with or without accompanying charges.88 During a resisting arrest incident, an officer may allege they received an injury during the encounter. In this particular analysis, the Board looks specifically at misdemeanor resisting arrest charges where there is no alleged injury charged as a part of the crime and the sole charge is resisting arrest. Penal Code section 148, subdivision (a) provides the following elements the prosecution must prove beyond a reasonable doubt to convict a person of a resisting arrest:

I am certain of its source of The CA-DOJ/RIPA Advisory Board's inspiration, especially since they failed to mention the BWC outrage of 243,000 unrecorded encounters in last year's report, and how it shall have impaired former years. These RIPA folk are people who adopted, adapted and used the unsupported claims, unsupported by BWC evidence that impugned an entire race, or two.

Since you dears were afraid of looking under rocks to expose the **race-based** non-recording decisions that underlay the filth, I did the next best thing. I examined the impact on the basis of the **predominant ethnicities** in the places to which officers were dispatched, i.e. the places that appear in **Unmatched_expected.xlsx**; an exquisitely and appropriately named file. I did so with data and information provided me by Officer Jericho Salvador, many years ago. Again, I did so because your endeavour was part of a deep-dive; a deep-dive made necessary by an SDPD claim that the obscene use-of-force disparities, especially those involving Blacks, resulted from interactions with **certain types of people** in **certain places**. You doubtless are familiar with the putrescent expressions that were used, which were widely regurgitated, by the obedient press. As you know, your City Auditor colleagues became involved when the SDPD could not document their claim

using local data. They went to Oklahoma, and Cincinnati, seeking support.

Distilled to its essentials, this is what I did and found.

- 1. I attempted to match items from the ARJIS-produced Unmatched_expected.xlsx to The Open Data Master Stop Records, using what remained of the heavily expurgated or redacted data that was made available; namely Stopdate, and location. Location is Street name and Beat. In the over 243,000 records at which matching was attempted, less than 3,000 encounters had commonality, using the aforementioned items. These items form the widest reasonable matching criteria. More narrow, or precise data-matching selections, would have produced fewer matches. Moreover, because of the heavy cleaning aor redaction, very little more precise data was available in Unmatched_expected.xlsx. Again, most items that would have worked towards precision were just not there. Indeed, when StopTime was included, only about 290 matches were found. Unmatched_expected.xlsx is the correct name, even though I expected more matches.
- 2. Next I looked at encounters that produced Traffic Stops, since these are almost all certainly RIPA-reportable. There are about 24,000 of these. Since the overall matches are just 3,000 there was no need to do any more matching, since no less than 21,000 Traffic-related stops were not present in RIPA-reported files.
- 3. I matched SDPD-provided Service Area data, which data describes the predominant ethnicities in each Service Area. It showed that for my SDPD-provided **Service Area** table, from which a handful of Beats is missing, 53% of the unrecorded stops were in places that are **Predominantly Black and Hispanic**. Blacks and Hispanes are 36% of San Diego's population.

I do not **for a moment** believe that only 10% of "dispatched" or other police-interactions are **RIPA-reportable**, the inverse is more likely. Accordingly, I invite your speculation of the impact on SDPD reported RIPA records for the two impacted years.

Things are exactly as I feared; perhaps they are worse.

I toyed with providing you a video of all this, but figured that you could duplicate these devastating results, with little effort, and much will.

If you need anything, just ask.
