SFPUC dispatched crews, issued an I-Info Alert and notified TIDA and DEM, who issued an AlertSF notification. Grid power was restored to a majority of the outage area at approximately 7:45 PM and full grid power was restored at approximately 10:25 PM. Cause was identified as blown fuses along overhead high voltage infrastructure on Avenue I.

On Monday July 24th at approximately 4:31 PM portions of Treasure Island including the residential neighborhood and Job Corps campus experienced a power outage. SFPUC dispatched crews, issued an I-Info Alert and notified TIDA and DEM, who issued an AlertSF notification. Grid power was restored at approximately 7:55 PM. Cause was identified as bird strike to overhead high voltage lines.

On Monday July 24th at approximately 6:45 AM portions of Treasure Island including the residential neighborhood and Job Corps campus experienced a power outage. SFPUC dispatched crews, issued an I-Info Alert and notified TIDA and DEM, who issued an AlertSF notification. Grid power was restored at approximately 8:10 AM. Cause was identified as bird strike to overhead high voltage lines.






Accomplishments

- posted images from our collection on social media to build community and foster public interest in what the island offers today.


- provided historic context for the permanent public markers being designed and installed to commemorate the lives lost in the Port Chicago disaster.




Celebrating **Fleet Week** on Treasure Island:
