- October 2023 Contracts Report
- Request for approval of a New Contract with MOSIMTEC, LLC to procure data analysis utilizing simulation modeling in support of SFDPH for their Behavioral Health system. The total proposed contract amount is \$109,600 with \$0 contingency for the term of March 1, 2023 through February 29, 2024 (1 year).

Information Regarding Providing Remote Public Comment
