for Artwork Placed Upon PRIVATE PROPERTY under VARA and CAPA

The artist,Matt Evans, has designed a work of visual art ("the Artwork") asdescribed below. The Artwork will be located at the address below, with consent fromNeha Marfatia(hereinafter referred to as the "Property Owner").

Aerial view of the Bay Area at night, with full moon and stars, transitioning to

rolling hills, covered in California poppies, finally revealing a dawn sky.

As a condition of the Property Owner's approval and authorization to create the Artwork on the Property, Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Artwork and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989)("CAPA"), or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights (collectively "Moral Rights Laws"), with respect to the Artwork, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the Property Owner or any future owner of the Property. If the Artwork is incorporated into a building such that the Artwork cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Artwork, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the Property, and its agents, officers and employees, for Modification of the Artwork.

The Property Owner, or any future owner of the Property, has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Artwork, in whole or in part without prior notice to the Artist. However, if the Property Owner, or any future owner of the Property, modifies the Artwork without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Artwork in accordance with 17 U.S.C. § 106A (a) (2).

The Property Owner has no obligation to pursue claims against third parties for modifications or damage to the Artwork done without the Property Owner's authorization. However, the Property Owner may pursue claims against third parties for modifications or damage or to restore the Artwork if the Artwork has been modified without the Property Owner's or Artist's authorization. In the event that the Property Owner pursues such a claim, Property Owner shall notify the Artist, and Artist shall cooperate with the Property Owner's efforts to prosecute such claims.

There is an existing mural on the North wall, painted in 2020 by Oakland artist Timothy B.






The proposed location spans a small entry gate near the top of the hill and takes a 90-degree turn at the bottom.

Design Sketch

1. At the top of the hill the mural starts out with a full moon surrounded by wisps of cloud and stars in the deep night sky.



2. The sky gives way to an aerial view of the Bay and the scattered twinkling of city lights.



3. City lights become undulating hills and patches of vegetation and trees.





4. Down at the other end of the wall, the sequence ends on a moonlit bed of California poppies, their petals tighly closed against the cool air.

Ten Year & Beyond Extended Maintenance Plan

Matt Evans is our resident muralist. He is a core member of St Mary's Park Greening and a neighborhood homeowner whose art studio is located in the ground floor of his home. The fact that he both lives and works a mere two blocks from the mural affords us a unique opportunity for its long-term maintenance and upkeep.

The mural will be coated with an anti-graffiti sealant for easy cleaning. SMP Greening will provide any tools needed for graffiti removal and a convenient location on their website for direct notification of damage or vandalism to the mural.

Extended Upkeep

Matt has committed to be on call, free of charge, to address any vandalism or graffiti within 48 hours of an incident, beyond the traditional 10-year period. In the event of significant damage to the mural surface, Matt has also committed to ongoing repair and upkeep of the painted surfaces using leftovers or acquiring new paint as needed.

Monitoring

Matt regularly drives by 201 College Ave and will keep a close eye on the state of the mural. The homeowner, **Neha Marfatia**, knows Matt personally and will be able to alert him immediately if anything is amiss. The core members of SMP Greening (also residents of the neighborhood) will be trained in the graffiti cleanup procedure and are prepared to keep an eye on the mural whenever they walk or drive past it.

Matt will also perform a formal and thorough inspection annually on the anniversary of the mural's completion.


