

# Laguna Honda Hospital Executive Team Report

- The California Department of Public Health and Department of Health Care Services recertified Laguna Honda Hospital in the Medicaid Provider Program.
- More than 95% of residents are supported by Medicaid.
- This recertification was the direct result of our team proving, in multiple rigorous surveys, that we meet the highest standards for resident care and safety, fire life safety and operations.



#### **Application for Medicare Recertification**

- On August 23, we submitted our application for Medicare recertification.
- We were able to submit our application, because of Laguna Honda's work and dedication, and commitment to continuous improvement.
- As of now, we are subject to a full survey by CMS, which could happen at any time, and without notice.
- Our goal is to demonstrate to CMS that we meet the highest standards of resident care and safety, fire life safety and operations.

- Throughout the recertification process, we have remained dedicated to our residents.
- Their health, safety, and wellbeing are our top priority.
- We remain confident that Laguna Honda is the best place for our residents to receive care.

#### **Action Plan Update**

- The Centers for Medicare and Medicaid Services (CMS) 90-Day Monitoring Survey #3 took place in June.
- In July, we submitted our proposed Action Plan in response to the June survey, as well as other non-monitoring-survey findings, to CMS.
- The proposed Action Plan includes approximately 300 milestones for Monitoring Survey #3 and 150 milestones for non-monitoring-survey findings.
- We have submitted 257 milestones for Monitoring Survey #3 and 109 milestones for non-monitoring-survey findings.
- In collaboration and partnership with the Quality Improvement Expert (QIE), LHH and the QIE have mutually agreed to pause milestone reviews, effective 8/24/23, during the current CMS Medicare Survey window, meaning the Medicare recertification survey can occur at any moment. Upon completion of the CMS Medicare recertification survey, the milestone reviews will resume.


#### **Action Plan Related Trainings**
