


Dear President Cindy Elias and San Francisco Police Commissioners:

Summary of Complaints Received in June 2023

The Department of Police Accountability received a total of **69** cases in **June 2023**, **63** SFPD complaints and **6** SFSO complaints. Compared with a total of **47** cases, **44** SFPD complaints and **3** SFSO complaint, in the same period last year, the **June 2023** case total is **1%** lower than the five-year average and is **47%** higher than the previous year.


From January through June, the DPA received a total of **399** new cases, **378** SFPD complaints and **21** SFSO complaints. Compared with the **347** cases filed during the same period in 2022, **336** SFPD complaints and **11** SFSO complaint. The June year to date case total represents an **15%** increase in new complaints over last year.
