## Firearm Discharge Review Board

In the 2<sup>nd</sup> Quarter of 2023, the Firearm Discharge Review Board reviewed the following completed Officer-Involved Shooting and Discharge cases.

- OIS 22-004
- OIS 22-002

## Officer-Involved Shooting 22-004

A SFPD officer was the subject of an on-going criminal investigation that was being conducted by investigators from the Investigative Services Detail (ISD).

On June 14, 2022, the ISD investigators obtained a search warrant for the subject officer, their residence, and their vehicles.

Prior to serving the search warrant, the ISD investigators contacted the subject officer's personal attorney. The attorney agreed to assist with the subject officer's cooperation during the search warrant service.

On June 15, 2022, the ISD investigators and the attorney responded to the subject officer's residence in San Francisco to serve the search warrant.

Upon arrival, the ISD investigators maintained surveillance while the attorney contacted the subject officer by cellphone.



## **Officer-Involved Shooting 22-004 (cont'd)**

The subject officer agreed to exit the residence but had not done so after approximately 20 minutes. The attorney acted on their own accord, breached the garage door, and made entry into the residence, while ISD investigators remained outside.

Moments later, the ISD investigators heard a gun shot which came from inside the residence. Seconds later, the attorney reappeared and stated the subject officer shot themselves and was deceased.

The ISD investigators entered the residence and requested SFFD medics to respond.

The subject officer was transported to Zuckerberg San Francisco General Hospital where they were later pronounced deceased.

## Officer-Involved Shooting 22-002

On April 15, 2022, at approximately 0006 hrs., an off-duty officer was asleep inside their residence in Concord, CA.

The officer was awoken by the sound of gunfire outside their residence.

The officer looked out their bedroom window and observed an unknown subject standing across the street from the residence while shooting at their relative who was seated inside their vehicle.

The officer grabbed their off-duty firearm and yelled numerous times for the suspect to stop.

The suspect directed his attention toward the officer and began shooting at them.

The officer returned fire toward the suspect while using their off-duty firearm.

## Officer-Involved Shooting 22-002 (cont'd)

The suspect fled the scene in an unknown vehicle.

The local law enforcement agency responded to the scene and conducted an investigation.

The suspect was never identified or located by law enforcement.

The officer and their relative were not injured during the incident.

It is unknown if the suspect was injured.

There were no criminal charges filed against the officer.
