Officer-Involved Shootings

Officer-Involved Shooting (OIS) Summaries

OIS 22-002:

On April 15, 2022, at approximately 0006 hours, an officer was off duty at his residence in Concord, CA. The officer was asleep when he was awoken by the sound of gunfire. Looking out his bedroom window the officer saw an unknown suspect shooting at his son who was in his personal vehicle. The officer grabbed his personal handgun and began yelling at the unknown suspect to stop. The suspect turned and began to shoot toward the officer and the officer fired his personal firearm at the suspect in self-defense. The suspect then fled the scene in an unknown vehicle. The suspect was never identified or located by law enforcement. The officer and his son were not injured during this incident. It is unknown if the suspect was injured.

OIS 22-004:

On June 15, 2022, officers from the Investigative Services Detail (ISD) responded to the private residence of an officer in San Francisco. They were going to attempt to serve a search warrant as the officer was the subject of a criminal investigation. Prior to responding to the residence, the officers met with the subject officer's personal attorney. The attorney responded to the residence as well in order to attempt to facilitate the subject officer's cooperation. Upon arrival, the attorney spoke to the subject officer via telephone. The subject officer agreed to exit the residence but had not done so after approximately 20 minutes. The attorney then on his own made entry into the house through the garage while the ISD officers waited outside. A gunshot was heard, and the attorney came back out and advised the subject officer had shot himself and appeared to be deceased. ISD officers entered the home and began rendering aid to the subject officer as well as requesting SFFD medics respond. The subject officer was transported to SFGH by medics and was later pronounced deceased at SFGH.
