Vice Chair Hollins discussed the importance of Reparations and the work the body has done. Chair McDonnell wrapped things up and talked about the mobilization of allies on September 19.

Member Erving wants to make sure that Black folks are staying in touch while moving reparations forward as policy is drafted. Wants to prioritize reparations for seniors.

Member Landry discussed mobilization and importance of Hip Hop Community. Member Berry talked about the Hip Hop Congress recognizing Reparations efforts. How to engage each department, inviting department heads to report back to the AARAC before it sunsets in January, 2024.

Member Martin talked about community engagement through Glide Memorial Church and how to educate the public.

Vice Chair Hollins talked about the San Francisco African American Reparations community participation list.

Brittni Chicuata, Director of Economic Rights Division discussed the Google list of allies created by the State Reparations advisory body and a Google form this body can use.
