For the last of these, it has been proposed that rules on the frequency of inspections be placed in the bylaws, which have been edited accordingly. The bylaws have also been updated to reflect the changes associated with the creation of the Homelessness Oversight Commission. Finally, the Policy Subcommittee recommends an increased level of involvement by the SMC Chair, e.g., to be notified of serious complaints as well as to approve Investigation findings.
