Purpose of Contract:

To provide overflow capacity when there is insufficient Residential Treatment or Withdrawal Management availability in San Francisco to meet the needs of residents, and there is an immediate need for a placement. This agreement will provide funding for up to five total dual diagnosis residential treatment slots in any one of the following three programs: (1) Men's Residential Home (\$415 bundled daily rate), (2) Women's Residential Home (\$415 bundled daily rate), and (3) Women and Children's Home (children up to five years with mother) (\$465 bundled daily rate).
