**BACKGROUND**

Article V, Sections 10 and 11 of the Third Amended and Restated Bylaws of the Treasure Island Development Authority ("Authority Board") states that:

**Section 10. Place of Directors' Meetings.** Meetings of the Authority Board shall be held at the principal office of the Authority unless a different place is designated by resolution of the Board or in the notice of such meeting.

**Section 11. Regular Meetings.** The Authority Board by resolution may provide for the holding of regular meetings and may fix the time and place of holding such meetings.

Authority Board Resolution 99-01-01/20, approved January 20, 1999, sets the current regular meeting location for Authority Board meetings as San Francisco City Hall Room 400. Authority Board Resolution 02-90-4/10, approved April 10, 2002, set the current regular meeting time and date for Authority Board meetings as the second Wednesday of each month at 1:30 p.m.

Today's item seeks to memorialize the regular meeting and on-Island special meeting schedule of the Authority Board of Directors for 2024. All monthly meetings shall continue to be held on the second Wednesday of each month at 1:30 p.m. at San Francisco City Hall Room 400, except for the April and November meetings which shall be held on Treasure Island at 749 9<sup>th</sup> Street, Treasure Island.

This item will also memorialize the Housing, Infrastructure, Transportation and Sustainability Committee meetings. These meetings will be held on the first Friday of the month at 9:30 a.m. at San Francisco City Hall Room 416.

The time of the on-Island meeting shall be properly noticed to the public. Special meetings of the Authority Board of Directors, or subcommittees of the Authority Board of Directors, shall be properly scheduled and noticed to the public as the need for such meetings arises.

4 WHEREAS, Naval Station Treasure Island is a former military base located on  
5 Treasure Island and Yerba Buena Island (together, the "Base"); and,

6 WHEREAS, The Base was selected for closure and disposition by the Base  
7 Realignment and Closure Commission in 1993, acting under Public Law 101-510, and its  
8 subsequent amendments; and,

9 WHEREAS, On May 2, 1997, the Board of Supervisors passed Resolution No. 380-97,  
10 authorizing the Mayor's Treasure Island Project Office to establish a nonprofit public benefit  
11 corporation known as the Treasure Island Development Authority (the "Authority") to act as a  
12 single entity focused on the planning, redevelopment, reconstruction, rehabilitation, reuse and  
13 conversion of the Base for the public interest, convenience, welfare and common benefit of  
14 the inhabitants of the City and County of San Francisco; and,

15 WHEREAS, Under the bylaws of the Authority, the Authority Board of Directors meets  
16 regularly on a monthly basis and also holds properly noticed additional as-needed special  
17 meetings throughout the year; and,

18 WHEREAS, the Authority wishes to memorialize the regular meeting schedule of the  
19 Board of Directors for 2024; now, therefore be it

20 RESOLVED, That the Board of Directors hereby approves the Authority Board of  
21 Directors Regular Meeting Schedule for 2024 in the form attached hereto as Exhibit A; and,

23 FURTHER RESOLVED, That the Board of Directors hereby approves the Housing,  
24 Infrastructure, Transportation and Sustainability Committee Regular Meeting Schedules for  
25 2024 in the form attached hereto as Exhibit B.
