





## **DTSC PUBLIC NOTICE**

Department of Toxic Substances Control – Our Mission is to protect California's people, communities, and environment from toxic substances, to enhance economic vitality by restoring contaminated land, and to compel manufacturers to make safer consumer products.

### **Proposed Land Use Covenant** Southgate Road Realignment Area, Yerba Buena Island

The California Department of Toxic Substances Control (DTSC) plans to establish a Land Use Covenant for the "Southgate Road Realignment Area," an approximately 8-acre area in the center of Yerba Buena Island. The Site consists of four parcels within the San Francisco Assessor's Block Map 1939. Two of the Yerba Buena Island parcels overlap with Site 29B on Treasure Island. LUCs restrict certain types of land use and activities to ensure the long-term protection of human health and the environment. Environmental investigations conducted in 2019 and 2020 found metals and total petroleum hydrocarbons as diesel above levels acceptable for unrestricted use on three of the four parcels. Land use restrictions are proposed for the three parcels to ensure the Site is managed safely into perpetuity. The Site is being transferred from the United States Coast Guard to the Treasure Island Development Authority.

The Land Use Covenant would require the development of plans that describe how to safely handle and dispose of remaining contamination if encountered during future construction work. Certain land uses would be prohibited, for example: residences, hospitals, schools and childcare facilities. In addition, there would be annual inspections and Five-Year Reviews of the Site. DTSC has concluded that these land use restrictions will provide long-term protection of human health and the environment.

### Convenio de Uso de la Tierra Propuesto Southgate Road Realignment Area, Yerba Buena Island

El Departamento de Control de Sustancias Tóxicas de California (DTSC) planea establecer un Convenio de Uso de la Tierra (LUC) para "Southgate Road Realignment Area," un área de aproximadamente 8 acres en el centro de Yerba Buena Island. El Sitio consta de cuatro parcelas dentro de San Francisco Assessor's Block Map 1939. Dos de las parcelas de Yerba Buena Island se superponen con el Sitio 29B en Treasure Island. Los LUC restringen ciertos tipos de uso de la tierra y actividades para garantizar la protección a largo plazo de la salud humana y el medio ambiente. Las investigaciones ambientales realizadas en 2019 y 2020 encontraron metales e hidrocarburos totales de petróleo como el diésel por encima de los niveles aceptables para uso sin restricciones en tres de las cuatro parcelas. Se proponen restricciones de uso de la tierra para las tres parcelas a fin de garantizar que el Sitio se maneje de manera segura a perpetuidad. El Sitio está siendo transferido del United States Coast Guard al Treasure Island Development Authority.

El Convenio de Uso de la Tierra requeriría la elaboración de planes que describan cómo manejar y eliminar de manera segura la contaminación restante si es que se encuentra durante las labores de construcción futuras. Ciertos usos de la tierra estarían prohibidos, como por ejemplo: residencias, hospitales, escuelas, y guarderías. Además, habría inspecciones anuales y revisiónes quinquenales del Sitio. El DTSC ha llegado a la conclusión de que estas restricciones de uso de la tierra brindarán protección a largo plazo para la salud humana y el medio ambiente.

Esta determinación se considerará definitiva 35 días después de la fecha de este aviso. 

#### One Third of Homeless Veterans Live in California. Here's Newsom's New Approach to Help Them

Lost Coast Outpost, November 6, 2023

California has poured billions of dollars into finding homes for unhoused veterans, but the number of former military service members living on the street has held steady for almost a decade. Today, a third of the nation's unhoused veterans are in California.

Tori Gibson of San Francisco is one of them. She's been looking for a stable place to live since she left the Navy seven years ago, and it hasn't been easy for her. She left the service in part because of health issues that continue to debilitate her.

Now 32 and undergoing a gender transition, she's struggling to make ends meet.

"It was just a really bad spiral of just more disability and then less money and no support," she said.

She's searching for a new start as Gov. Gavin Newsom proposes a significant change in the state's strategy for ending veteran homelessness. His plan, included in a \$6.4 billion mental health bond he's sending to voters in the March primary election, would set aside funding specifically for veterans with serious behavioral health conditions.

That's a shift from California's last two major efforts to fund housing for veterans, both of which created units for a general population of former military service members.

The first effort began in the late 1990s, when the state built seven new veterans' homes over a period of 17 years. Today those veterans homes are underused. They were built to house about 2,400 people, but only 1,575 veterans live in them. The 300-unit veterans home in Barstow was so underutilized in 2020 that Newsom moved to close it as he braced for a pandemic recession, although lawmakers blocked him from shutting the site.

The second push centered on a pair of ballot measures voters approved in 2014 and in 2018 that allocated \$4.6 billion to build housing specifically for former military service members. The money created the Veterans Housing and Homelessness Prevention Program, which has supported the construction of about 3,250 housing units for veterans to date.

Veterans advocates and state officials view the programs — along with federal efforts led by the Department of Veterans Affairs — as successful in reducing homelessness among former military service members. In the last 12 years, veteran homelessness in California has decreased by more than 30%.

But the trend in California mostly accounts for gains made during the Obama administration, when veteran homelessness peaked nationwide and the Department of Veterans Affairs moved aggressively to place former troops in housing. Since 2014, the number of homeless veterans in California has mostly plateaued around 10,000 to 12,000 people, according to annual counts released by the Department of Housing and Urban Development.

Alex Visotzky, senior California policy fellow at the National Alliance to End Homelessness, said the high numbers of veteran homelessness result from the challenges veterans face on returning home in California's competitive housing market.

"When housing markets are unaffordable and incredibly competitive, those with the greatest needs are going to be more likely to fall out," he said.

Newsom's new strategy in the mental health bond, advocates say, should help those most in need. The California Department of Veterans Affairs estimates that half of the state's unhoused veterans suffer from some kind of behavioral health issue.

The money in the bond would go to the state's Department of Housing and Community Development, which would work with CalVet "to focus specifically on housing veterans experiencing behavioral health challenges," said Assemblymember Jacqui Irwin, the Thousand Oaks Democrat who wrote the bill that ultimately put the bond on the ballot.

Studies have shown veterans are overrepresented in the nation's homeless population. They may experience personal challenges, such as post-traumatic stress disorders or other mental health issues as well as disabilities related to their military service.

"Transitioning from that very specific culture and society to civilian life is a lifelong process," said Amy Fairweather, director of policy at the veterans advocacy group Swords to Plowshares. "If you do have any physical or mental disabilities, dealing with those and trying to re-enter civilian life can be very difficult."

#### California's veterans homes

California's long history of providing housing to former military service members dates to 1884, when it opened an estate in Napa County as the state's first veterans home. That site is still in operation, housing around 600 veterans on a picturesque property in wine country.

Altogether, the state now has eight veterans homes. The two largest homes are in fairly remote communities — one is in Napa County's Yountville and the second is in Barstow in the Mojave Deserts. Moving to them can mean living at a long distance from a veteran's family. That geography somewhat limits interest in the homes.

The homes account for the lion's share of CalVet's \$650 million annual budget. Some advocates have called on the state to put money into programs that would benefit people who don't necessarily want to live in a veterans home.

"The state should keep its promises to the current home residents, but as things change, the program needs to be less structured on just providing room and board for a very limited number of people and more structured on providing skilled nursing facility care for those who need it," said Ethan Rarick, executive director at Little Hoover Commission, which published a report on the veterans homes in 2017.

Outside of the veterans homes, California approved a series of bonds meant to help military service members find housing beginning in 2008. The Veterans Bond Act, passed that year, provided \$900 million to veterans through the CalVet Home Loans Program.

In 2014, California passed an initiative creating the Veterans Housing and Homelessness Program, which put \$600 million toward building multi-family homes for veterans. A second ballot initiative in 2018 gave another \$4 billion to the program.

The federal Department of Veterans Affairs, meanwhile, has kept up steady funding for housing vouchers that can provide a place to live for former troops. The Veterans Affairs Supportive Housing program, commonly known as HUD-VASH, was a centerpiece of the Bush and Obama administration's efforts to curb veterans' homelessness. It provides rental assistance to over 100,000 veterans nationally.

A steep drop in veteran homelessness

The number of homeless veterans in the U.S. peaked in the Great Recession, when the VA in 2007 reported some 154,000 former troops were homeless.

At that time, Fairweather of Swords to Plowshares said many of those deployed in the Iraq and Afghanistan wars were starting to come back home "to a society that wasn't prepared for it."

On top of that, they and older veterans struggled in the economic downturn, which led to more unemployment and homelessness.

"It all came together in a way that was really disadvantageous to the veterans," she said.

Last year, the VA estimated about 33,000 veterans were homeless nationwide. According to the 2021 annual homelessness assessment report by the federal Department of Housing and Urban Development,

more than half of them are over age 55. The data also shows that Black veterans are more likely to be homeless than veterans belonging to other races.

Advocates say veterans can be reluctant to ask for help.

"When veterans ultimately fall down that hole into homelessness, what is happening along with that is that they're losing connection with friends and family, because they're ashamed that their life is falling apart and it's hard for them to ask for help," said Stephen Peck, president of the veterans support organization U.S. Vets.

San Francisco native and Army veteran Latoya White has struggled to stay housed in the dozen years since she left the service. She has found it difficult to afford rent even though she was able to keep decent jobs at a grocery store, the San Francisco airport, and now as a city bus driver.

She was unfamiliar with the resources the VA offered to veterans, like housing vouchers.

"I've always had benefits through my job. I don't think that then the VA had as many resources as they have now. I did go to the VA and they're so limited on what they could help me with. So, you know, I just went and got a job and I just was really self sufficient," she said.

After sleeping in her car and couchsurfing for several years, White reached out for help from the advocacy group Swords to Plowshares. That led her to transitional housing, and then to an apartment in San Francisco this June through the HUD-VASH program.

"A lot of us didn't even know anything about the HUD-VASH program," said White, 34. "A lot of veterans don't even know that there is assistance out there for them."

What does Newsom want to do?

Putting the money into the mental health bond comes with a tradeoff.

In advancing Newsom's mental health plan, lawmakers amended an early version of Assemblymemer Irwin's veterans' housing bill that would have issued more bonds for the existing veterans' housing program. Without new funding, the program that supports construction of multi-unit veterans' housing is expected to run out of money in 2024.

Still, representatives for Newsom's ballot measure in a written statement said the bond would create more capacity to help former troops.

"Proposition 1 adds new money for California's most vulnerable veterans without any redirection or reprioritization from the current program. Without Proposition 1, there would be zero funding for homeless veteran housing moving forward, which is why the measure is so critically needed," the statement read.

All together, the ballot measure going to voters includes \$6.4 billion to fund projects for behavioral health issues and those at the risk of homelessness. It also includes a proposal to adjust how the state spends money it collects for mental health services from a tax on personal income over \$1 million, aiming to direct more of the money to housing.

The \$1 billion for veterans housing will be distributed in the form of loans and grants by the Department of Housing and Community Development.

Representatives from veterans' groups say the program's success could hinge on getting the word out, and providing services that provide a path out of homelessness.

At U.S. Vets, Peck said the nonprofit strives to create a community where veterans help veterans.

"Building that community is really important," he said. "A federal veteran who's been through the process already is probably more effective than we are as social workers."

Gibson, who currently lives in transitional housing provided by Swords to Plowshares, has started to find that community through the nonprofit.

"I talked to them about how I'm struggling with some issues and they are pretty open and supportive about it," she said.

Gibson hopes that federal and state services fund more community-oriented programs like hers, so more veterans are able to feel like they are home.

#### San Francisco set to start zero-emissions ferry-building programme in 2023

The San Francisco Water Emergency Transportation Authority's (WETA) rapid electric emissions-free ferries (REEF) programme has set target dates to begin construction of its first zero-emissions ferry as well as the start of commercial operations as part of a phased plan to overhaul its fleet with five new ferries.

WETA relayed the news as part of a strategic partnership deal with Finish maritime technology group Wärtsilä, which will lend its expertise on fleet electrification and systems integration to the REEF project.

In early 2021, WETA launched a study intended to create a foundation for its plan to replace San Francisco Bay's ferry fleet with new zero-emissions vessels. The municipal study finalised its 'Blueprint for Zero Emission Vessel Transition' in early 2023, determining a new fleet would need electric propulsion systems and electric charging infrastructure.

With the REEF project's conceptual phase nearing completion, WETA said it will soon begin the project's vessel construction phase.

The REEF project foresees building three 150-passenger ferries and two larger ferries capable of carrying 300 or more passengers. The project is also planning to build floating battery charging units.

"The construction of the first electric-powered vessel is slated to commence before the conclusion of 2023, with commercial operations expected to launch in 2025," a statement from new REEF strategic partner Wärtsilä said.

"We're proud to operate the cleanest high-speed ferry fleet in the nation, but a zero-emissions future for our system is within reach," WETA executive director Seamus Murphy said. "Wärtsilä's expertise and experience will be incredibly valuable given the complexity our ferry decarbonisation programme entails."

Wärtsilä said the strategic partnership project around the REEF project was one of "several" the company would carry out work on under the umbrella agreement with WETA.

On its LinkedIn social media page, WETA confirmed it is working with Wärtsilä "and additional partners", with "more news on this front soon".

WETA's website says its long-range development plan calls for new terminals in the Treasure Island, Mission Bay, Berkeley, Redwood City and South Bay areas of San Francisco, as well as in the Carquinez Strait, with an initial plan to shift 50% of its municipal vessel fleet to zero emissions by 2035.

#### Yerba Buena Island's condos are outselling SF's other luxury buildings. Here's why.

Sumeetha Jacob had been living in Fremont for 20 years when the pandemic hit and she decided she wanted a change. While droves of people were leaving San Francisco, she thought it was the perfect time to buy a place in the city. She searched for about a year, mostly looking at downtown condo buildings, but never found anything that felt right. Then she learned about The Bristol.

The new housing development on Yerba Buena Island wasn't yet completed, but even before she embarked on her hard-hat tour, she was hooked. "I parked my car and stepped out and was immediately blown away by the breathtaking views around," she said. "The water views, the Golden Gate, Alcatraz, the ships and sailboats. I thought, what? There's a place where you can see all of it?"

The views are just one reason the property is currently outselling other luxury buildings in San Francisco. The Bristol outpaced similarly amenity-heavy buildings in unit sales, especially ones located downtown, by more than two times in the past 16 months. But it's not just stunning vistas that are luring buyers across the Bay — the building is winning over buyers thanks to reduced interest rates, a separation from downtown and the island's neighborly feel.

The Bristol is just the beginning of the massive, 8,000-unit Treasure Island/Yerba Buena Island Development Project, with Yerba Buena Island's housing units the first completed. The tiny island attached to the manmade Treasure Island and accessible by the Bay Bridge will have more than 250 homes spanning a condo building, single-story residences and townhomes, with access to a private clubhouse, a pool, 72 acres of parks and 5 miles of walking trails.

Condos at The Bristol range from \$599,000 for a 612-square-foot studio to nearly \$3 million for an approximately 2,200-square-foot three-bedroom. The development began selling units in March 2021 and has sold a total of 46 residences out of 124 — just 37% of what's available.

But that's considered a success amid a tough Bay Area housing market, especially for amenity-laden luxury buildings. Condo sales in September 2023 in San Francisco were down 19% year over year when compared with 2022, according to data from the California Association of Realtors. In February 2023, the SF condo market hit the lowest point it had seen since the 2009 recession, a Compass report shows.

Median downtown condo prices are the lowest they've been since 2014, according to Compass data.

Crescent, a luxury building in Nob Hill that also started selling its units in early 2021, has only sold 14. It's far from a perfect comparison — the much smaller building includes 44 residences "many with outdoor rooms" — but it also offers stunning views and is not located in downtown San Francisco. The Bristol is outpacing the building by 229%.

San Francisco's Four Seasons Private Residences at 706 Mission St. may be the epitome of the struggling condo market. The ultraluxury building (units start at \$2.3 million) has sold just 14 of the 146 available units since June 2019 (and no, Steph and Ayesha Curry weren't buyers).

One Steuart Lane, a 20-story building that also boasts sweeping bay views from its location just off the Embarcadero, is more than 50% vacant, with 43 of 120 total units sold since it began sales in February 2020, according to Compass data. A pop-up on its website currently advertises "fall price reductions" of "\$300,000 to over \$1 million on select homes."

"Pretty much everyone is offering something, whether they're advertising it or not," said Paul Zeger, CEO of real estate sales and marketing company Polaris Pacific, which represents many high-end condo buildings in San Francisco, including One Steuart Lane, Crescent and the Four Seasons Residences. Unadvertised incentives might include the developer covering the costs of HOA dues for a buyer for two years or reimbursing them for closing costs.

Since One Steuart Lane started offering discounted units last month, the building has doubled the number of people coming in for viewings, Zeger said.

When it comes to buying a home, though, the ultimate deciding factor is whether a buyer can afford it. As interest rates hit a 23-year high last month at 8% and buying power decreased, many buyers opted out of the market. But The Bristol is offering something that can bring them back into the market — a 5.5% interest rate.

The project's developer, Wilson Meany, is offering what's called a "buy-down," where the company works with a bank to contribute upfront cash to earn a lower rate for a certain amount of years. This helps buyers with the initial monthly payments, giving them some relief until rates go down and they can refinance. Krysen Heathwood, a senior managing director at Compass, said she doesn't know of any other development offering such a deal, but expects that to change. "I think we're going to see more and more of it to encourage sales," she said.

Even with a enviable interest rate, The Bristol's not-technically-SF location may also be helping its sales. Downtown has lost its appeal since the pandemic for some, said Heathwood, and they see Yerba Buena as a safer alternative. "Perceived security is still a real thing," she said.

Its location is a good fit for people who have been called back from remote work to offices in SF, she said, since the commute is easy on the short ferry ride. It's also attracting attention because of its

novelty, Heathwood added. "It's an entirely new neighborhood," she said. "There isn't another development out there like that. It's very intriguing."

Yerba Buena's rebrand is a big step in building more housing for San Francisco, but the development is a controversial new chapter for the island. City-owned housing, largely for low-income residents, stood on the island for 16 years (plus some former, abandoned naval housing), but those residents were evicted and offered the choice to move into houses on neighboring Treasure Island. Those homes will also be demolished soon and many hoped to return to Yerba Buena Island but feel the high-end units are now out of their price range.

Housing on Treasure Island has also been called into question, as radiological assessments found lingering radioactive waste in residential portions of the island from its time as a Navy base.

But the development is one of the most unique opportunities out there right now, Heathwood said. During Jacob's home search, The Bristol stood out because it allowed her to feel connected to the city without actually being in the thick of it. The access to nature was incredibly appealing, she said, and she also found other features she was looking for in the units, like high ceilings and lots of natural light. She said some friends were concerned about her choice to live on the island, warning her she might feel isolated and far from essential services. But now that she's a resident, she feels the opposite: "I have a community here," she said. "It feels like family here."

Lynn Bell, another Bristol resident who moved to the island a little over a year ago, decided to check out the building because she'd lived in SF for 35 years and wanted a larger space. Every time she crossed the Bay Bridge to or from work in the East Bay, her eyes would drift over to the development taking shape on the island visible from the highway.

"It's so close to the city, yet it provided this sense of tranquility that had gone away for me," said Bell, 63, who later became the director of sales for the development.

There's a common thread among residents of all ages about "being connected," she added. Neighbors are friendly with each other and there are plenty of get-togethers, whether it's celebrating a birthday or taking one of the community fitness classes. She thinks it'll only get better when the island club is completed (estimated in 2024).

It feels like "island living" in the middle of an urban environment. "It's like you've gone on a mini vacation," Bell said. "...There's this extra level of something here."

#### S.F. hangar converted into cathedral for hot new racket sport — and it's not pickelball

Treasure Island developer Chris Meany has long believed that if his company built the housing and infrastructure, the rest of the stuff that makes a neighborhood — culture and entertainment and community gathering places — would grow organically.

But even Meany couldn't have predicted that the organic growth would include a 60,000-square-foot cathedral to a little-known but fast-growing sport that some say could knock pickleball off its perch of being the No. 1 alternative to tennis for racket sport enthusiasts.

In September, entrepreneurs Matias Gandulfo and Lucas Tepman, a pair of Argentine transplants, opened Bay Padel, a club dedicated to padel, a sport that has a huge following in South America and Europe, especially Spain, where there are roughly 20,000 courts. But it had yet to find that type of popularity in the Bay Area.

The opening of the padel club comes as about 1,000 units of housing are under construction on Treasure Island and the adjacent Yerba Buena Island. The first of these, the 250-unit Isle House, will open in the middle of next year, with the rest to follow.

"What matters at the end of the day is, can we create, not just the homes and infrastructure, but a neighborhood that is consistent with and true to San Francisco," Meany said.

The club is located at Hangar 3, the historic airplane hangar that, between 1990 and 2010, was used as sound stages for movies such as the Robin Williams sci-fi comedy "Flubber," "The Matrix" and "Indiana Jones and the Last Crusade." Now, there are six padel courts — four inside and two outside — as well as a co-working space, gym, lounges, pro shop and art gallery. They are in the process of adding a restaurant. There will also be four pickleball courts.

The Treasure Island club is just the start for Bay Padel, which has raised \$25.9 million from investors, according to public filings. A second club will open next spring in the Dogpatch, with plans for clubs in Sunnyvale, San Jose, Santa Cruz and New York.

Like pickleball, padel is played on what looks like a shrunken tennis court. The ball resembles a tennis ball, but is slightly smaller and less pressurized. Each court has glass walls on all four sides, and the ball can be played off the wall, similar to racquetball or squash. The surface is thick turf hardened with compressed sand.

Gandulfo came to the United States to play college soccer and study engineering, while Tepman, who has worked in politics and as a venture capitalist and chief financial officer, came to study for a masters at UC Berkeley. They met at a barbecue in Oakland four years ago. Like other gatherings of Bay Area transplants from South America, the conversation quickly turned to padel, with both lamenting that there were no courts in the region.

"We both grew up playing every weekend — it was a family thing," Gandulfo said.

But they found it was not easy to find suitable venues. The lob is a central part of the sport — so high ceilings are required. Padel also requires clear space — there can't be a bunch of columns in the way. Many of the spaces they looked at in the southeast part of San Francisco were zoned for industrial uses and recreation was not allowed.

They learned there were reasons why nobody had managed to open a padel club in the Bay Area.

"If you talk to every player who comes here and ask them if they ever thought about opening a padel facility, every one of them will say 'Yes,' " joked Tepman. "It turns out it's not that easy — I wouldn't recommend it."

The first hire the duo made was Marcel Felder, a retired professional tennis player from Uruguay, who was put in charge of programming for both padel and pickleball. Felder also grew up playing padel in South America and watched the sport take off in the late '80s and early '90s, only to lose steam.

"A lot of courts opened up and business was not good," he said. "There were too many courts and too few players."

Back then, the walls around the court were concrete, as was the surface. The hard surfaces were rough on the knees and the opaque walls made it impossible for spectators to watch the game. But, over time, the sport evolved. Glass walls replaced concrete while a composite of artificial turf and compacted sand became the go-to playing surface, which cut down the number of injuries.

The combination of glass walls and a gentler surface has changed the game, Felder said.

Scott Colebourne, treasurer of the United States Padel Association, said the number of padel clubs in the United States has doubled in the past year, from 35 to about 70. "There are literally clubs opening every other week," he said. "Interest in the sport is exploding."

The association has about 2,000 members who play tournaments and are on the national circuit.

"I think it combines the best elements of both pickleball and tennis. It's super social and easy to play, like pickleball," Colebourne said. "However, it's a little more athletic than pickleball, a little faster, and more of a workout."

The costs associated with padel are higher than with pickleball, because it requires the glass box. Courts cost between \$60,000 and \$80,000 to build. Rates for a court can average about \$35 per person per hour. Members at Bay Padel play for \$25 and are entitled to some free play, yoga classes, clinics and other amenities.

Oakland resident Antonio Sierra, who is from Mexico and played college tennis at the University of Central Florida, said he was "the first one here when they opened the doors."

"I've been wanting to play so bad for the longest time," he said. "I've been watching my friends in Mexico play on Instagram and it was killing me that we had no place to play in the Bay Area."

For Rodrigo Cruz, a Mexico City native who lives in Oakland, the Treasure Island location was fortuitous because he and his wife Janeen already work on the island. Their salsa company, Kuali, has a commissary kitchen there. "Oh man, I am obsessed with that game," said Cruz. "Padel is taking over big time."

He has been playing once or twice a week since it opened in September.

"The new plans for the island are fantastic. It's beautiful, bro," he said. "You can play outside and watch the bridge lit up at night. I've met people from all over the world — Spain, France, Argentina, Costa Rica."

Gandulfo said he and his partners were unsure whether people would travel to Treasure Island to play. That hasn't turned out to be a problem. Players come by bus, ferry, bike and car. About 50% are from the South Bay, and the rest from San Francisco and Oakland. They are starting to get players who live or work on the island. The padel court doesn't take up the entire hangar and Tepman and Gandulfo have discovered random rooms that look like they may have been painted for "Indiana Jones" scenes. There is also a large collection of stone sculptures from the 1939 and 1940 World's Fair. The Bay Padel group plans to name the padel and pickleball courts after movies filmed there — including "Flubber."

"Flubber is amazing," said Tepman said, "One of my favorite movies."

#### Treasure Island school dedicated to helping homeless youth

TREASURE ISLAND, Calif. (KRON) – The mission of the Life Learning Academy on Treasure Island is trying to give children in San Francisco an opportunity they might not get anywhere else. For the past 25 years, this academy has been helping troubled or homeless teens refocus their lives.

Co-founder Teri Delane sees the need for this resource because she too benefited from a similar home after running away at age 13.

"Age 14 I had a needle in my arm, getting arrested, incarcerated as a juvenile for drugs," she said. "The last time I overdosed, I woke up in the hospital and who was there? A mentor. He said you are going to San Francisco Delancey Street Foundation, and that's where I saved my life."

Delane has several master's degrees and a PhD in clinical psychology. She is living proof that you can turn your life around.

Now, she is helping teens like Nixon Ooi turn their lives around as well. Nixon says looking back, it was a life-changing experience.

"I remember just walking in and I had my whole life in a backpack. It was such a surreal experience," he said. "Growing up in such a bad environment, coming to a quiet dorm, I remember feeling welcomed a lot."

He was homeless at age 16, but Nixon's mind is now on college. He is submitting college applications to eight universities, and he plans on studying business.

"Honestly, I think it's a miracle and I say that genuinely. I ran away at 16. And running away, the odds are against you," he said. "To have a home, friends, jobs... I feel like my life has been rebuilt."

Delane says at Life Learning Academy, they practice "radical love."

"Radical love to me means accountability, safety, great school, academics, paid internships, but they earn it all," she said.

This academy is a public charter school – part of the San Francisco Unified School District.
