I. CALL TO ORDER

II. APPROVAL OF MINUTES

The Commission reviewed and approved the minutes from the regular Commission meeting on October 25, 2023.

III. DIRECTOR'S REPORT

Director Ellis gave thanks for recent election results where women, girls, and abortion rights won the night in states across the country.

Director Ellis shared that the Department recently hosted the Cork, Ireland delegation, San Francisco's sister city, and discussed a grant with Sexual Violence Centre Cork.

Director Ellis shared that the Department is in the early planning stages of the 2024 Shift Happens Policy Summit and provided the website link to sign up for updates and watch highlights from the 2023 Shift Happens Policy Summit to invite commissioners to share with their networks.

Finally, Director Ellis highlighted the Domestic Violence Awareness panel hosted by the Department between Black Women Revolt Against Domestic Violence, La Casa de Las Madres, and the Victim Services Division of the District Attorney's office, and shared the Department's plan to expand their collaboration with the Victim Services Division and the Office of Victim and Witness Rights.

Nancy Cohen of the Gender Equity Policy Institute presented a six-month progress report on the Gender Equity Policy Institute's work on the Abortion Access Landscape Analysis being conducted on behalf of the Bay Area Abortion Rights Coalition.

President Miry thanked Dr. Cohen, stating that it was a powerful presentation.
