# 3. Results of Survey given to JPC Commissioners on the effectiveness of the Commission. (Discussion)

A. President Brodkin introduced Nancy Rubin who served as facilitator for the retreat. Nancy outlined the activities and timeline for the retreat. Commissioners and those present introduced themselves and set their relationships with the Commission and their intentions for the retreat. This was followed by an activity to review and discuss the results of the survey completed by JPC Commissioners: Effectiveness of the Commission.

B. Public Comment: Queen Vanessa Banks – expressed concern about hearing that the commission is not working with staff and not being on the same page. She sees that those present want to hear from the community, but she's concerned that organizations the Juvenile Probation funds should be here and they're not. Someone should be monitoring them to keep them accountable. Some of those organizations should be here helping the commission and the department do the work. Queen Vanessa speaks for Hunters Point/District 10.

# 4. Review of Commission goals from 2022 – 2023 – Action on Commission goals by Department and Commission, possible additional Commission goals and their priority goals. (Discussion & Possible Action)

- A. Nancy facilitated discussion and review of Fiscal Year 2022-2023 goals developed during last year's JPC retreat. Each of last year's goals were reviewed and Commissioners were asked to answer the following questions for each goal: 1) how do we interphase with this goal from our governance point of view (what's the Commission's role as it related to this goal? What did we do?) and 2) what could we have done differently?
- B. Public Comment: Queen Vanessa Banks spoke of her role as an urban consultant and mentions the need to have stipends for families and community members to participate in the commission and its processes, to inform the commission's work, and to bring their voices and issues forward.

She encourages commissioners and the department to rely on the community to help them implement the work they think of and set forth during these meetings.

- A. President Brodkin reviewed a summary of bylaws, including actions the Commission may take, and recommended that the scope of the Finance Committee is expanded to include governance and communication.
