


Fit into Overall System of Care:





Services for Children, Youth (<21), and Families:



RFGA #7781 - Mental Health Services Act (MHSA) School-Based Mental Health Programs At San Francisco Unified School District (SFUSD):

- These programs are designed to serve children and youth who exhibit behavioral health difficulties
- These programs aim to:
 - Reduce risk factors, promote wellness, and reduce stigma related to mental health
 - With special attention to at-risk and underserved populations, particularly children and youth who are:
 - At-risk of failing school
 - Frequently absent or truant
 - Display challenging behaviors in the classroom
 - Have been exposed to trauma



Scope of Services:

Program 1: Behavioral Health Services and Trauma Recovery services at SFUSD High Schools

- 1A: Behavioral Health Services at Balboa Teen Health Clinic located at Balboa High School
 - Case management (including referral and linkage services) for students and parents on a scheduled and drop-in basis
 - Individual and group counseling for students and families
 - Crisis intervention
 - Community building/violence prevention events
- 1B: Trauma and Recovery Services for High School Students and Their Families
 - Truancy wrap-around support for the youth, caregivers and school staff
 - Trauma-related support, psychoeducation and treatment



Scope of Services Continued:

Program 2: Mental Health Services and Youth Early Intervention Program Consultation at SFUSD Elementary and Middle Schools

- 2A: Mental Health Services at Charles Drew College Preparatory Academy Elementary School
- 2B: Youth Early Intervention Program at James Lick Middle School and other schools based on yearly needs in Mission neighborhood
- Both programs focus on:
 - Serving all students who request services, with special emphasis on youth who exhibit behavioral health difficulties
 - Providing services to caregivers, families, and school personnel when appropriate
 - Tier 1 services: universal to all students, essential for strengthening school climate, relationships, and classroom instruction
 - Tier 2 services: targeted to selected students who are not responding to Tier 1 support, often given in small group settings
 - Adaptations and variations necessary for the corresponding schools and the community they are in

Scope of Services:

- The program services include:
 - Outreach and Promotion
 - Screening and Assessment
 - Mental Health Consultation
 - Individual Therapeutic Services
 - Typically, 6 to 8 sessions max per intervention period
 - Will refer to longer-term treatment services when appropriate
 - Group Therapeutic Services
 - Education, Prevention and Early Intervention for SUD related services
