Dorian Katz is an artist working in drawing, zines, comics and installations. Dorian has lived in the San Francisco Bay Area since the 1980s. She has over 20 years of organizing art shows and events mostly within Queer communities including as Center for Sex & Culture's gallery director from 2011 2019. Life in the bay as experienced as well as her historical knowledge of it deeply effect her perspective and art.

Dorian received a B.A. in Studio Art from UC Santa Barbara in 1991 and an MFA in Art Practice from Stanford in 2011. Her art has been exhibited nationally and published widely. She enjoys presenting inclusive views of sexuality with humor and beauty in ways that make it accessible and desirable to any audience.

In the past few years, Dorian has gotten more interested in self publishing her art in mini comics, coloring books and drawings grouped by themes. She enjoys sharing her art in other affordable and accessible formats like prints, stickers and small original drawings.

1 Describe your work in detail How do you make it?

I make drawings by hand on paper in a cartoony style. I make small, affordable originals suitable for market. I also have stickers plus digital and riso prints made of my drawings. For my coloring books and comics, I take the scans of each drawing and do the layout on my computer and then either print them at home or at copy shops. I assemble the pages and staple them with staples that will not rust.

2 Where did you learn your craft?

I have been drawing my whole life and learned how to make zine and comics from my friends. I did go to school for art too. I received an MFA at Stanford University. At school my peers thought of me as an outsider artist; in a way they are right. Still, learned a lot from them about writing and art.

I have taken art classes at colleges. My friends also make comics and I am part of the queer cartoonists community in the Bay Area. My friends generously have taught me most of what I know about putting together comic books..

Sumptuous ink lines, fanciful lettering and a cartoony style are my visual hallmarks. I enjoy the act of drawing and relishing in my aesthetics. I make a mini-comic every other month around a different theme from mermaids to sex work and fashion week in the femme animal queendom. I turn my art into small affordable items because I find it very satisfying to share it with other people who can relate to it's messages. I want it to be affordable.

5 What makes your work different from other artists and craftspeople making similar items?

This is a difficult question. There are many artists making comics with anthropomorphic animal characters. I've been doing it much longer than most. My content is LGBTQUIA oriented. I am inspired by scientific data on animal behavior, sexuality and gender; this is not very common. The quality of lines in my art is flowing and calligraphic; this is rarely occurs in art that is frequently humorous and irreverent. People do say that my style is distinct.
