Artist Biography (Please provide a short biography about yourself and your craft):	Born in Fall River, Mass. in 1968. Educated at SFSU and UNC in the Arts, film, and theatre. I began making stained glass mosaics at an Eco Resort in the Virgin Islands in 2004. I moved to Asheville, NC in 2007 where I began freelancing professionally. Since, I have produced thousands of mosaics with commissions from coast to coast. I had a gallery in Hendersonville, NC Fayetteville, NC, and Wilmington, NC. I relocated to Portland, Oregon in 2016 and landed in a gallery in San Francisco, CA in 2023 located at 909 Sutter Street within the Nob Hill area.
	It is all about the light with my stained glass mosaics, its movement and tone throughout the day or, specialty lighting such as projection. I enjoy watching the character of my creations change during a partly cloudy day.
	Stained glass mosaics are unlike traditional stained-glass as you work with different tools and techniques. The glass is set in stoned and sealed. There is more freedom in mosaics than traditional stained glass. Besides stained glass there are a plethora of objects that can be placed in a mosaic.
	Oil painting is another artform that I am attracted to and have attempted more canvases with great delight.
	I live with my loving companion up on Nob Hill and enjoy the scenic beauty of California.
1. Describe your work in detail. How do you make it?	l do glass on glass mosaics, a technique of bonding glass to glass then setting in stone using grout and sealer. Tables, Plates, Glass Block Walls, Water Fountains, Plates, Fish Tanks, Counter tops.
2 Where did you learn your craft?	In the Virgin Islands working at an Eco Resort that had an art center. I was asked to do a mosaic and painting for the entrance to the glass blowing studio. I sought out a mosaic artist who gave me a bucket of glass and showed me nippers to cut. However, she did not do glass on glass. I thought how lovely that would be and found a glass top table thrown in the forest and transformed it into enchantment. I gave that table to a Potter when I moved away and she still has it on her deck.
