Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime down 39 percent; homicide down 50 percent; rape down 71 percent; robbery down 27 percent; assault down 44 percent; human trafficking down 100 percent. Property Crimes down 50 percent; burglary down 42 percent; motor vehicle theft down 33 percent; arson down 63 percent; larceny theft down 55 percent. Gun violence is down 38 percent compared to 2023; Three shooting incidents this week; total 4 fire-arm related incidents resulting in 5 victims YTD. One homicide for the week; there are a total of 1 homicides YTD with 1 resulting from a firearm; 0% overall clearance.

Significant Incident: One homicide, shooting, 16th Street and Terry Francois, no suspect in custody. Three non-fatal shootings caused injury to four victims. One of the four victims, 1/1/2024 23:49, 1000 Block of Connecticut, Bayview, two victims, both children, family was asleep inside their residence when the victim's father heard gunshots coming from outside, two children within the residence sustained gunshot wounds and were transported in stable condition, non life threatening injuries, victims were eight months and seven years old, no arrests, still under investigation. 2nd Shooting, Turk and Taylor, 1/1/2024 00:18, the victim was a passenger in a vehicle and suddenly realized they had been shot, police were in the area and were flagged down and an ambulance was summoned, the victim was transported, is in stable condition, no arrests, under investigation. On 1/1/24, occurred on 24th and mission, 3200 block of 24th street in the Mission, sometime after midnight, the victim locked the doors of his jewelry shop the night before and on new year's day, he found out that the lock had been cut, doors pried open, and a significant jewelry had been taken, that is still under investigation, Supervisor of that district hosted a town hall for the residents, Captains Hurwitz and Lieutenant Anderson attended. Multi vehicle arson that occurred on the 300 block of Park Street in the Ingleside district, 12/31/23 21:28, unknown suspect was seen pouring gasoline on four parked vehicles, that person then ignited the vehicles and continued walking westbound on the 300 block of Park toward the 300 block of Holly Park Circle, suspect then poured gasoline on the front porch stairs of a residence and lit the home on fire, this residence at the time had over 30 people in it who were having a celebration, including 15 children who were present for a New Year's Eve party, 911 was called, fire was extinguished and nobody was injured, under investigation and no arrests have been made at this time. Last significant event, series of ATM related burglaries, another one this past week at the 3700 block of Balboa Street, 1/3/24 03:40, the witnesses observed a vehicle drive through glass doors/window at the Bank of Amercia, officers arrived, they observed that an atm had been taken, ongoing investigation, believe that's a part of a series. Stunt driving event, 1/7/24, various locations. SFPD officers were ready, received information that they were coming into the city, Officers deployed through our stunt driving response protocols, approximately 100 vehicles arrived in the city and were met by SFPD officers, the group proceeded to the area of Chase Center but were met by additional Officers who disrupted the group as they attempted to set up a stunt driving event,

all of the vehicles left the area by 02:45 and went back across the Bay Bridge to different cities. Two fatal traffic collisions, Junipero Serra and Palmetto, 1/1/24 10:26, driver was found to be intoxicated, solo collision. The second was South Van Ness and 18th in the Mission, 1/4/24 10:15, pending investigation.

Significant arrest: Two major injury collisions, Eddy St and Van Ness, Northern, 1/4/24 at 02:28 Officers approached a double parked vehicle, found that one of the occupants was wanted, as officers attempted to have the wanted suspect exit the vehicle, the vehicle fled, suspect collided with another vehicle and all three occupants fled on foot, but were located and taken into custody, two guns were recovered from the vehicle. There was also a stabbing that occurred at the unit block of sixth street in the Tenderloin, this occurred on 1/6/24 18:40, 6:40 P.M. The subject and victim were in their building and acquainted with each other, as the victim exited the elevator near his unit, the subject stabbed him with a knife, the suspect was arrested at the scene.

Strategies: Drug Market Agency Coordination Center, last year there was over 119,610 g of fentanyl that has been seized, which is the equivalent of 59.8 million lethal doses of fentanyl. There were over 900 arrests for drug dealers and over 1000 arrests for drug users. DMAC operation is ongoing for the week. The first week of the year, yielded 4052 arrests and 1400 grams of narcotics seized.

DPA Director's Report

- Report on recent DPA activities, and announcement

Executive Director Henderson reported the following: In the year 2024: 7 cases opened; 6 closed; 311 pending; 0 cases sustained; 31 cases past 270-day; 0 cases mediated. SFPD Cases received in the **past five (5) weeks:** 63. Central-11-Officers used excessive force, pointed a firearm at a person, and made inappropriate comments. Southern-6-An officer exhibited rude behavior when the complainant inquired about the investigation of their missing vehicle. Additionally, the officer failed to investigate the complainant's vehicle theft properly. The officer racially profiled the complainant, pulled him over, and issued a fix-it ticket. Bayview-2-The complainant stated he was arrested, handcuffed, and injured by unknown officers sometime in 2016. Mission-8-Officers failed to investigate and were discourteous. An officer failed to take a harassment report. Northern-7-Officers threatened to tow the complainant's vehicle for expired registration and violated homeless rights. The complainant stated that he was assaulted at Safeway, and the security guard did not do anything. Officers who went to file a police report for him were rude and aggressive with him. Park-6-Officers failed to address the complainant's concerns, failed to generate an incident report, and engaged in inappropriate and biased policing. The officers failed to investigate properly and take the required action. Ingleside-3-Officers failed to take required action concerning multiple missing person reports. Officers engaged in inappropriate behavior/comments. An officer gave out an inaccurate phone

number. Taraval-4-Officers were dispatched to the complainant's call regarding the neighbor, but they claimed the address did not exist and did not make contact with the complainant. Tenderloin-5-Officers used excessive force during the arrest of the complainant. The officer instructed medical staff to inject the complainant with Narcan against his will unnecessarily. The officer also used inappropriate language. Not Applicable-10-Referrals. Out of Town-1-The complainant stated police conducted a warrant with no cause on her son's apartment and threw items of clothes on the floor.

Audits: December 21st DPA issued its Full Audit Report on SFPD's handling of Officer misconduct. Scheduled for presentation on 2/21/24. In December, DPA initiated a new audit of SFPD's stop data, in the planning phase.

Outstanding Issues: DPA and Controller's Officer following up with SFPD on the status of the open recommendations, from October 2020, on the first audit, Use of Force Audit.

Outreach: DPA participated in the Richmond Station November Meeting. On Thursday, DPA will participate in the fireside chat at Manny's, a community focused meeting learning space here in San Francisco, will feature Outreach Communications Coordinator Carolyn Weisinger, who is moderating a conversation with Policy Director, Janelle Caywood, as well as Director of Recruitment Tinnetta Thompson, focus of the conversation will be centered around DPA 101- overview, explains the functioning of the department.
