- How to approach Deep Dives:
  - Chief proposes that Commissioners decide what they want to know/own request/ work with JPD on shaping the presentation and proposed next steps.
    - It's important for Department to provide context.
  - Discuss first in Committee.
  - What are the next steps on the out of county youth discussion?
    - Chief is going to review with the judge/ discuss transfer outs.
- Public Comment:
  - Mollie Brown: Is there any context for "the honest conversation" with CBOs? How will this play out in a public commission meeting? How does role of DCYF play into this topic?
- Discussion:
  - Honest conversation with CBOs about strengths/ weaknesses/ what's working/ what's not? What are CBO organizational needs? What are they not getting from the city? What needs are not being met on the part of community providers? What needs are not being met by the Department? Higher level conversation about what needs exist in the community/ strengths/ weaknesses of the portfolio of available services. Need further discussion about best time/ venue for this discussion. Program Committee should address first – Commissioner Rodriguez requested this agenda item.

#### 5. Presentation on Juvenile Probation Department's FY 2024-2025 and FY 2025-2026 Budget by Katherine W. Miller, Chief Probation Officer (Discussion Only).

- Discussion
  - Slide 13: Does detained include DJJ commitments?
    - No these are arrests.
  - Slide 3: Commissioner Brodkin expresses concern re: Mayor's key drivers increased cost of CBOs in relation to increased City government costs.
    - Ordinance passed last year requires city to increase grants with GF by 3% every year for cost of living.
  - What is rationale for not meeting Mayor's budget request?
    - Given that the biggest cost is personnel, JPD org chart should be included.
  - Given that detentions have declined why can't we close a unit?
    - Chief: 5 Units operating regularly: 2 units for SYTF; 1 unit open for girls; 2 units for boys. Essentially, need for classification purposes (gender, age, interpersonal)
  - Community Investments:
    - Clarify that Justice Reinvestment=Community Investments

- Show sources for Community Investments
- Explain change in community investments over time: the bump, why FY25/26 is lower than prior year,
- Juvenile Hall tenures: Succession planning/ how are we preparing for JJC retirements?
- Social Worker class change: DHR denied JPD's request to change classification. Need HSA's permission to use their SW classification.
- How many staff do we need? What is appropriate caseload? How to address out of county youth? Different youth need different levels of supervision. How to address criticisms of JPD work quality/ caseloads?
  - Chief: We have to be able to do the work that comes our way. Through 4 years of the job, discussions with staff, CON mapping process, I am very clear that our staff are at their max. In different budget climate, I would have asked for more staff. Staff are overloaded in a way they haven't been in a long time. I want kids and families to experience government supporting them the way they are supposed to. Reforms have produced more paperwork/ requirements, court is asking more.
- Public Comment:
  - Mollie Brown: Justification for "new" positions in Admin; LCR Staff? Did JJC FTE decline include LCR staff who were no longer needed? Interested in citation/ detention flip; Caseload – how is workload affected on cite vs. detention?

  - Don't have the right-size conversation at the same time as the budget. What are the needs of the community/ how do we best structure the department to meet those needs?
  - Chief: Perhaps appropriate to discuss at Finance & Governance Committee, in addition to November Full Commission meeting. Notes that JPD has made significant staffing cuts since FY 19/20.
