Resident Engagement

This month, TI Advisors took proactive steps to engage directly with key stakeholders. Our team has held engaging discussions with Catholic Charities and The San Francisco Housing Authority. Our focus is to ensure residents have a smooth transition into their new units. Building on our previous efforts, we introduced DAHLIA Doorhangers, which included a QR code to the DAHLIA application, to raise awareness of the application process. Admiral Security assisted TI Advisors in placing door hangers at all units managed by The Villages.

To enhance accessibility, TI Advisors have regularly office hours at Aracely Cafe every Wednesday. Our first few weeks of holding the office hours has proved successful, with 14 residents attending office hours in one day. The ability to accommodate walk-ins during these office hours has been particularly beneficial, offering immediate assistance to those who find this format helpful and accessible.

In a proactive gesture, **TI Advisors personally delivered copies of preliminary award letters to Star View Court Volunteer households.** As a part of this process, volunteers were allowed to schedule a **walkthrough of the Star View Court.** Due to extreme weather conditions, tours scheduled on January 31st and February 1st, have been rescheduled to February 7th and 8th to ensure residents' safety and convenience.

TI Advisors collaborated closely with The San Francisco Housing Authority (SFHA) to assist residents holding Section 8 vouchers to foster a deeper understanding of their transition into Star View Court. TI Advisors and the team held a productive meeting with D'Jon Scott-Miller, the executive director at SFHA, to plan two upcoming informational sessions. These sessions aim to guide residents holding Section 8 vouchers.

Lastly, in response to feedback from the board and residents, TI Advisors addressed the request for increased communication via text messages. Collaborating with One TI, **our team is working to coordinate SMS communications**, ensuring that essential updates and information reach residents promptly and effectively.



What information is available?

All informational documents are easily accessible online: TI Advisors gathered all future housing information and have included it in every digital communication from TI Advisors. Residents also have access to an online resource folder in their preferred language where they can access this information at their convenience.

TI Advisors have an electronic calendar link: Using this link and including it in all communications makes it easy and convenient to schedule a meeting time with a TI Advisor: https://calendly.com/tiadvisor/meeting

TI Advisors have standing office hours at Aracely Café every Wednesday. While walk-ins are welcome, we encourage residents to schedule sessions to ensure dedicated time with an advisor. To schedule an in-person session, residents may use this link: https://calendar.app.google/zaFBvLNAExi45zPN7

Monthly Summary

In January, TI Advisors focused on distributing information about the DAHLIA application, collaboration with key partners, and responsive communication methods. A significant focus was encouraging Vested Residents to apply for the upcoming affordable and inclusionary housing opportunities in 2024.

We aim to engage residents through a multipronged approach, leveraging a variety of touchpoints to ensure all target audiences can be reached, including those with limited English proficiency, people with various work schedules, and those who may fall into the digital divide. We are on the island using door hangers, making phone calls, using emails, and providing online and in-person resources, and offering to meet over the phone, via video conference, and in person.

TI Advisors are also contacting all Legacy Households to confirm the current occupancy of each resident included on The Villages lease. This will support TIDA's goal to issue Move Out Notices to Legacy Households, as soon as it's feasible, aiming to do so before the spring. Move Notices will be issued following the order of Legacy Household Ranking and matching of Legacy Household bedroom counts with the available Legacy Transition Units at Star View Court.

Challenges faced

While our community engagement initiatives have increased, we have encountered challenges related to the DAHLIA application process. Initially, TI Advisors informed residents that the application would open in mid-February. However, due to unforeseen circumstances, there have been some delays, and we are currently working towards opening the application, tentatively in early March. We understand the residents' anticipation and appreciate their patience as we navigate and address these unexpected circumstances.

Outreach & Social Media

Community engagement continues through social media posts, posts on Next Door Treasure Island, fliers on the community boards, weekly pantry bags, mass emailing, and partnerships with the TI housing providers.

One TI continues to partner with the housing providers to outreach to the TI community on future housing opportunities in the Star View Court housing development. We have also begun to support Home Rise with the planning of the transition of their units to Catholic Charities and the John Stewart Company.

The Island-wide Community Meeting will be held on February 28th via zoom. Please see the notice attached.


One TI is hosting a New Resident Orientation on Saturday, 2/10 from 10:00 – 12:00 PM. We will review the revised Welcome Packet.

Treasure Island Museum Report to TIDA ~ February, 2024



Since our last report, our staff and community volunteers have:

- initiated the process of transferring our collection database, including photographs and documents from our archives, to a system that will allow free online access to the community, teachers, and historians; this project is funded by a generous donation from PCL Construction and Stantec.
