### 3. General Public Comment

Public commenter Jessica expressed appreciation for the work of the subcommittee and suggested enhancing privacy protocols and investigative processes.

#### **4. Approval of Meeting Minutes from November 7, 2023 (Action Item)**

There was no public comment.

#### **5. Department Updates & Announcements**

Mike Makstman thanked former COIT Director Jillian Johnson for her contributions to PSAB, welcomed Jane Gong as a new member of the subcommittee, and introduced Damon Daniels as the latest member to join COIT Staff. Julia Chrusciel gave an update on the status of the Annual Surveillance Report

There was no public comment.

#### **6. Surveillance Technology Policy Amendment Review: Security Cameras (Action Item)**

Guy Clarke and Joyce Mamiya presented on behalf of the Airport on their Pre-Security Camera Amendments.

Recommendations posed by members of the subcommittee include:

- Be explicit in the policy that the technology does not have facial recognition capability
- Include data protection terms and conditions that might apply to contractors with this data, in the section titled “Sanctions for Violations”

There was no public comment.

Molly Peterson made a motion to move this item forward with the aforementioned clarifications, Michelle Littlefield seconded.

The motion was approved by Mike Makstman, Jane Gong, Michelle Littlefield, Molly Peterson, and Georg Wolfl. Guy Clarke abstained from the vote.

#### **7. Surveillance Technology Policy Review: Web Content Filtering Technology (Action Item)**

Shane Thomas and Elisa Baeza presented on behalf of the Juvenile Probation Department on their Web Filtering Software.

Recommendations posed by members of the subcommittee include:

- Include language about sharing data in instances related to a court order or justice partner, under “Internal and External Data Sharing”
- Specify that only the destination website is captured, not user data

There was no public comment.
