- Mental Health Support/Therapy specific to support women's needs
- Safety for Women experiencing DV or who belong to the LGBTQ+ community, etc.
- Women's Event or 2- Day convention/Retreat for Women identified people
 - Create a space for women to feel feminine by providing beauty and luxury through hotel and spa services
 - Create a space for art and music to release tension and promote personal expression through creativity
- Remember to be intentional in creating an environment of compassion, love, empathy, sympathy when greeting clients
- Facilitate motivational speaking and job training events/workshops (remote or in person)
- Use research and data to facilitate more resources and centers for women
- Creation of more spaces for women in general
- Bring back block parties to build a sense of community
- Provide child care or child watch services at events/classes to assist women and families
- Provide a 24 Hour Access Point/Hotline for women who are in need
