A. SUBCOMMITTEE REPORT

There was more discussion of training. There needs to be more consistency across providers, and more done to evaluate whether staff have actually learn what they have been nominally taught. Members of the public continue to suggest that (1) mere compliance is not as important as substantive ongoing improvement in competency, and (2) the challenges that staff with lived experience face calls for more mental health support. Subcommittee Member Dobbs will ask HSH for information about the budgets shelters have for training, as well as how much discretion they have on what and how they provide this. CJ Ross suggests that SMC ascertain whether shelters are responding properly to complaints that are filed internally, i.e., not through the SMC. She put forth a tentative proposal.
