- i. ECOTE24-021 Brothers For Change INC, **dba Soulful Sundays**, O'Farrell St between Fillmore St and Steiner St – One Time Outdoor Event Permit to host outdoor entertainment and amplified sound with extended duration, February 18, 2024 to October 27, 2024, Every other Sunday (1st and 3rd Sundays) from 11:00am - 5:00pm.

Motion: Commissioner Thomas made a motion approve the permit with staff recommendations: staff recommends that applicant redo their outreach to the neighborhood with the correct information to allow feedback from the community in the area. During this time, we allow the event, at the discretion of the Executive Director, for a trial period of two Sundays: February 18 and March 3, 2024. They can then return for the March 5, 2024 hearing for further conditioning and discussion about approval for the event going forward with the schedule of allowing

entertainment for the 1st and 3rd Sundays of each month starting on March 17, 2024 to October 27, 2024; Vice President Wang seconded the motion.
