#### **BUSINESS DESCRIPTION**

On The Bridge Restaurant is an iconic Japanese restaurant located in Japantown. Opened in 1992, the restaurant was one of the first in San Francisco to specialize in yōshoku-style food, a fusion of Japanese and European cuisines. Today, they are best known for their Shinjuku-style chicken stock curry, beef stock curry, and yōshoku-style "wafu" pastas, along with their offerings of Japanese beer and sake.

On The Bridge Restaurant was opened in 1992 by spouses Mitsuhiro Nakamura and Yolanda Nakamura. Mitsuhiro is Japanese and Yolanda is Salvadorian. The two still own and operate the business today, along with help from their three daughters.

On The Bridge Restaurant attracts a diverse clientele of both locals and tourists; many customers share an appreciation for and curiosity about Japanese culture. This makes the restaurant a place for learning, embracing, and celebrating. According to the owners, "On The Bridge Restaurant is harmoniously located on a bridge connecting two essential malls, which hold a variety of Japanese-themed shops while being a bridge to Japanese culture where people can watch anime, read manga, learn about the various beers and sake from Japan, and eat yōshoku-style cuisine." It is a true cultural connector in San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:



- The business is associated with Japanese cuisine, specifically Shinjuku-style chicken stock curry, beef stock curry, and yōshoku-style "wafu" pastas.
- On The Bridge is located on the iconic Webster Street bridge in the Kinokuniya building in the heart of Japantown. Although it is a Category B (Unknown/Age Eligible) building, the building has important historical associations with the controversial redevelopment of the Western Addition as well as the presence of Japanese culture in San Francisco. In 2015, the unadopted Neighborhood Commercial Corridors Survey rated the building as "Does not appear significant under Criterion C/3 (Architecture/Design)." The building is within the boundaries of the ongoing San Francisco Citywide Cultural Resources Survey.

While the business itself is not mentioned in a historic context statement, the Japantown Historic Context Statement mentions the Redevelopment-era construction of the Japantown malls.

- On The Bridge Restaurant has been mentioned in the media numerous times, including articles in 7x7, the San Francisco Chronicle, Eater San Francisco, and KQED.
- With regard to racial and social equity, On The Bridge Restaurant is a family-owned business run by Japanese and Salvadorian owners. It is an important part of Japantown's cultural heritage, and it is especially important as one of the first restaurants in San Francisco to specialize in yōshoku-style dishes, such as curries, cutlets, and Japanesestyle hamburgers. On The Bridge Restaurant gives back to its community by donating gift cards to the Japanese Bilingual Bicultural Program's annual auction and by donating meals to the San Francisco Police Department in 2020.

I am writing to nominate On the Bridge, a Japantown staple known for its Yoshoku cuisine, to the Legacy Business Registry.

For 31 years, On the Bridge has provided Japantown with its unique cuisine and blend of Japanese culture and San Francisco spirit. Located in the oldest Japantown in the United States, On the Bridge does not only serve food, it also provides tourists and locals with a chance to experience an authentic manga kissaten-style dining that provides a comforting ambiance.

Mitsuhiro and Yolanda Nakamura, owners of On the Bridge, are a proud interracial couple, and their menu reflects a blend of cultures. Chef Nakamura is a pioneer in fusion cooking, providing customers with menu items like 23 different kinds of pasta and famous Shinjuku-style curries.

On the Bridge is part of Japantown's cultural fabric. Chef Mitsuhiro has participated in demonstrations of Shorinji Kempo, a form of Japanese martial arts, at the Cherry Blossom Festival for years. He has also served as a mentor for individuals with desires to travel to Japan, providing community members and customers with an education and appreciation of Japanese culture and traditions. They have demonstrated their commitment and involvement to the Japantown community through their annual donation of gift certificates to the Japanese Bilingual Bicultural Program's annual auction and meal donations to community serving organizations.

In addition to their popularity in Japantown, notable people like Chris Hart, a famous artist in Japan, Patti Smith, punk rock icon and frequent customer, baseball players, and Japanese variety show hosts have all dined at On the Bridge. Their extensive selection of Japanese sake and beer

Their dedication to the promotion of Japanese goods has earned them the Japanese Food Supporter Certificate, given out by the Japan External Trade Organization and the Ministry of Agriculture, Forestry, and Fisheries.

During the COVID-19 lockdown, On the Bridge lost 90 percent of their business due to its location in the interior bridgeway that connects the Japan Center's West Mall and Kinokuniya building. Despite going days without sales, Chef Mitsuhiro refused to give up, motivated less by money and more by a love of his craft and community. The resilience of On the Bridge, and many of the impacted small businesses in the neighborhood, is why Japantown is among citywide leaders in post-pandemic success.

My office sincerely appreciates the resilience of On the Bridge Restaurant and their commitment to Japantown and Japanese culture, and I am honored to nominate On the Bridge Restaurant to the San Francisco Legacy Business Registry.

#### **INTRODUCTION**

#### a. Describe the business. What does it sell or provide?

On The Bridge Restaurant sells Japanese food and drinks. On The Bridge values embracing the unique, weird vibes that one can only find in San Francisco. They are family owned restaurant with a Japanese papa and Salvadorian mama who have been passionately running the business since 1992 with their three daughters.

Chef Mitsuhiro Nakamura, a.k.a. the papa of the restaurant, has been studying Japanese sake and beers to one day become a sake sommelier with restaurant mama Yolanda Nakamura studying by his side. On The Bridge Restaurant offers a variety of sake and beer that share the beauty of different prefectures in Japan in hopes to take folks on an adventure with every bottle. If you don't know where to begin, don't hesitate to ask their staff. Cheers!

#### b. Describe whom the business serves.

On The Bridge Restaurant is located in Japantown, one of San Francisco's tourist attractions, but the restaurant serves both tourists and locals alike. The general similarities of the customers who frequent the restaurant are people who have traveled to Japan before, people who appreciate and respect Japanese culture, and people who want to learn about the diversity within Japanese culture. It is a place of learning, embracing, and celebrating.

#### c. In about 2-5 words (15-30 characters), describe what the business is known for.

Shinjuku-style chicken stock curry, beef stock curry, and yoshoku-style "wafu" pastas.

# CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

#### a. Provide a short history of the business, including locations and owners.

On The Bridge Restaurant was founded by spouses Mitsuhiro Nakamura and Yolanda Nakamura on September 22, 1992. It has been located in the storefront at 1581 Webster Street, #206, since it opened.

Mitsuhiro is Japanese and Yolanda is Salvadorian. They met at City College of San Francisco and enjoyed learning English together while getting to know the city. Mitsuhiro and Yolanda decided to start a business together because it was a dream of his to open a restaurant in San

Francisco. They decided on yōshoku-style cuisine because this is the cuisine Mitsuhiro was passionate about and reminded him of home.

On The Bridge Restaurant is situated literally on the Webster Street Bridge that crosses between the West Mall and the Kinokuniya Mall of the Japan Center Malls, hence the business' name.

"Besides describing the restaurant's physical location in the mall, the name 'On the Bridge' also represents the link that its yoshoku style dishes make between Japanese and European cuisines. Chef Nakamura says he was the first Bay Area chef to specialize in this style of fusion cooking, which traces its roots back to 1868, when Emperor Meiji first welcomed Western ideas as helpful for Japan's progress. Some non-Japanese diners may be unfamiliar with yoshoku's comforting standbys, but these are the dishes that Japanese mothers often make for their children: curries, cutlets, Japanese-style hamburgers, omu-rice (omelet stuffed with fried rice) and fish roe–studded spaghettis."<sup>1</sup>

Mitsuhiro and Yolanda's children are involved in the business, and show up at the restaurant on occasion, especially during festivals. Their youngest daughter manages the restaurant's social media accounts as well.

#### b. Provide the ownership history of the business in a consolidated year-to-year format.

1992 to Present: Mitsuhiro Nakamura; Yolanda Nakamura

### c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

On The Bridge Restaurant has never closed down since it opened in 1992 and even managed to remain open during the COVID-19 pandemic. The business receives a lot of support from family, friends, staff, community members, and customers.

# CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

### a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

On The Bridge Restaurant is "an eccentric, family-run restaurant that is indeed on the bridge between Japan Center's (Kinokuniya) and West Malls, and is known as much for its anime film and TV show collection as its menu of fusion foods like Japanese spaghetti and okonomiyaki

pizza."<sup>2</sup> The restaurant is famous for its Shinjuku-style Chicken stock curry, beef stock curry, and yōshoku-style "wafu" pastas. The business is also known for its famous "Loco moco," which is traditionally a Hawaiian dish. People do not go to On The Bridge Restaurant for sushi, tempura, or teriyaki. The regulars understand what yōshoku cuisine is.

For those not in the know, yōshoku (洋食, western food) in Japanese cuisine refers to a style of Western-influenced cooking. These are primarily Japanized forms of European dishes often featuring Western names. It is an example of fusion cuisine.<sup>3</sup>

On The Bridge Restaurant supports the Japanese Bilingual Bicultural Program. In addition, Coowner Mitsuhiro Nakamura has mentored many people who wanted to travel to Japan, learn about Shorinji Kempo (a Japanese martial art), and study Japanese. He and Yolanda Nakamura have also been a model to many people that an interracial marriage and unity can blossom into wonderful things such as their business, On The Bridge Restaurant.

#### b. Is the business associated with significant people or events, either now or in the past?

Many significant people have dined at On The Bridge Restaurant over the years, including athletes and celebrities. One of the regulars, Chris Hart, is now a famous artist in Japan. Currently, punk rock icon Patti Smith frequents the restaurant whenever she is in town for her concerts. Baseball athletes and Japanese variety show hosts have dined at the restaurant as well. They even have award-winning bartenders who have been regulars and enjoy the restaurant's diverse selection of Japanese sake and beer.

On The Bridge Restaurant co-owner Mitsuhiro Nakamura has participated in Japantown's Cherry Blossom Festival over the years demonstrating Shorinji Kempo, a Japanese martial art.

#### c. How does the business demonstrate its commitment to the community?

On The Bridge Restaurant donates gift certificates to the Japanese Bilingual Bicultural Program annual auction to support the education of Japanese culture. The business also donated meals to the San Francisco Police Department in 2020. The business owners educate customers on the diversity within Japanese culture.

#### e. Has the business ever received any awards, recognition, or political commendations?

On The Bridge Restaurant received a Japanese Food Supporter Certificate, which is only given to businesses that promote supporting businesses that support Japanese goods. This certificate is given out in partnership with the Japan External Trade Organization (JETRO), which is a nonprofit organization that connects businesses with the resources they need to successfully expand to Japan. This award is also made in partnership with the Ministry of Agriculture, Forestry, and Fisheries (MAFF).

### f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If On The Bridge Restaurant were to close, there would be one less establishment that is operated by a Japanese papa and Salvadorian mama in San Francisco and the Bay Area. It is important to celebrate Japanese culture and honor the culture by appreciating Japanese restaurants that are still operated by Japanese chefs, such as On The Bridge Restaurant. This restaurant is also one of the only places you can experience a manga kissaten style and feel like you are in Japan with our ambience, homemade meals, with warm San Francisco vibes. Manga kissaten are establishments where visitors can read from an extensive library of manga (Japanese comics). On The Bridge Restaurant is harmoniously located on a bridge connecting two essential malls, which hold a variety of Japanese-themed shops while being a bridge to Japanese culture where people can watch anime, read manga, learn about the various beers and sake from Japan, and eat yōshoku-style cuisine.

On The Bridge Restaurant is located inside the Japantown Kinokuniya building, which was established in 1968 as part of the controversial Western Addition redevelopment project that evicted over 8,000 residents. It is believed that the first wave of Japanese immigrants arrived in the 1880s, which is when Japantown became one of the first and largest Japantowns in the United States.

#### b. In a few words, describe the main business activity you commit to maintaining.

On The Bridge Restaurant is committed to serving yoshoku-style Japanese cuisine and proudly providing a variety of Japanese beers and sake.

### c. What is the plan to keep the business open in the long term beyond the current ownership?

Although the future is still undecided, Mitsuhiro and Yolanda Nakamura are leaning towards maintaining the legacy once they retire by keeping the business within the family or selling the business to owners who would keep the restaurant going.

#### d. What challenges is the business facing today?

On The Bridge Restaurant has faced numerous challenges since it was established in 1992. There has been discrimination with Asian hate crimes in the Western Addition. The COVID-19 pandemic caused regulations that changed weekly. Inflation has been a problem. Increasing credit card fees and delivery application fees have been challenging. And there has been a constant struggle of trying to keep the On The Bridge experience affordable and comfortable for customers and staff.

#### **Business Description**

On The Bridge Restaurant is an iconic Japanese restaurant located in Japantown. Opened in 1992, the restaurant was one of the first in San Francisco to specialize in yōshoku-style food, a fusion of Japanese and European cuisines. Today, they are best known for their Shinjuku-style chicken stock curry, beef stock curry, and yōshoku-style "wafu" pastas, along with their offerings of Japanese beer and sake.

On The Bridge Restaurant was opened in 1992 by spouses Mitsuhiro Nakamura and Yolanda Nakamura. Mitsuhiro is Japanese and Yolanda is Salvadorian. The two still own and operate the business today, along with help from their three daughters.

On The Bridge Restaurant attracts a diverse clientele of both locals and tourists; many customers share an appreciation for and curiosity about Japanese culture. This makes the restaurant a place for learning, embracing, and celebrating. According to the owners, "On The Bridge Restaurant is harmoniously located on a bridge

connecting two essential malls, which hold a variety of Japanese-themed shops while being a bridge to Japanese culture where people can watch anime, read manga, learn about the various beers and sake from Japan, and eat yōshoku-style cuisine." It is a true cultural connector in San Francisco.

The business's primary location at 1581 Webster Street, #206 is a Category B (Unknown/Age Eligible) structure on the southwest corner of Post and Webster Streets in the Japantown neighborhood. It is within the Japantown Neighborhood Commercial District (NCD) Zoning District and a 50-X Height and Bulk District. It is within the boundaries of the Japantown Cultural District, the Japantown Community Benefit District, the Japantown Special Use District, the Family Housing Opportunity Special Use District, and the Priority Equity Geographies Special Use District, as well as located within ¼ mile of an existing fringe financial service. It is located within the Japantown Mayor's Invest in Neighborhoods Initiative area.

#### **Staff Analysis**

#### **Review Criteria**

#### 1. When was business founded?

The business was founded in 1992.

#### 2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. On The Bridge Restaurant qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. On The Bridge Restaurant has operated continuously in San Francisco for 32 years.
- b. On The Bridge Restaurant has contributed to the history and identity of the Japantown and Western Addition neighborhoods and San Francisco.
- c. On The Bridge Restaurant is committed to maintaining the physical features and traditions that define the organization.

#### 3. Is the business associated with a culturally significant art / craft / cuisine / tradition?

Yes. The business is associated with Japanese cuisine, specifically Shinjuku-style chicken stock curry, beef stock curry, and yōshoku-style "wafu" pastas.

4. Is the business or its building associated with significant events, persons, and / or architecture?

Yes. On The Bridge is located on the iconic Webster Street bridge in the Kinokuniya building in the heart of Japantown. Although it is a Category B (Unknown/Age Eligible) building, the building has important historical associations with the controversial redevelopment of the Western Addition as well as the presence of Japanese culture in San Francisco.

5. Is the property associated with the business listed on a local, state, or federal historic resource registry?



Not as of the date of this Executive Summary. In 2015, the unadopted Neighborhood Commercial Corridors Survey rated the building as "Does not appear significant under Criterion C/3 (Architecture/Design)." The building is within the boundaries of the ongoing San Francisco Citywide Cultural Resources Survey.

#### 6. Is the business mentioned in a local historic context statement?

While the business itself is not mentioned in a historic context statement, the Japantown Historic Context Statement mentions the Redevelopment-era construction of the Japantown malls.

#### 7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. On The Bridge Restaurant has been mentioned in the media numerous times, including articles in 7x7, the San Francisco Chronicle, Eater San Francisco, and KQED.

#### **Racial and Social Equity Analysis**

On July 15<sup>th</sup>, 2020 the San Francisco Historic Preservation Commission adopted <u>Resolution No. 1127</u> centering Preservation Planning on racial and social equity. Understanding the benefits, burdens, and opportunities to advance racial and social equity that proposed Preservation Planning documents provide is part of the Department's Racial and Social Equity Initiative. This is also consistent with the Mayor's Citywide Strategic Initiatives for equity and accountability and with the Office of Racial Equity, which required all Departments to conduct this analysis.

The Legacy Business Program is deeply intertwined with these goals. One of the primary purposes of the Legacy Business Program is to maintain San Francisco's cultural fabric and to foster civic engagement and pride by assisting long-operating businesses remain in the city. The Legacy Business Registry was established to recognize longstanding, community-serving businesses that are valuable cultural assets of the city. These businesses, ranging from restaurants to art galleries to tire shops to community shelters, are key to sustaining the racial and social diversity in San Francisco and adding to the identity and character of our city and the many communities within it.

On The Bridge Restaurant is a family-owned business run by Japanese and Salvadorian owners. It is an important part of Japantown's cultural heritage, and it is especially important as one of the first restaurants in San Francisco to specialize in yōshoku-style dishes, such as curries, cutlets, and Japanese-style hamburgers.

On The Bridge Restaurant gives back to its community by donating gift cards to the Japanese Bilingual Bicultural Program's annual auction and by donating meals to the San Francisco Police Department in 2020.
