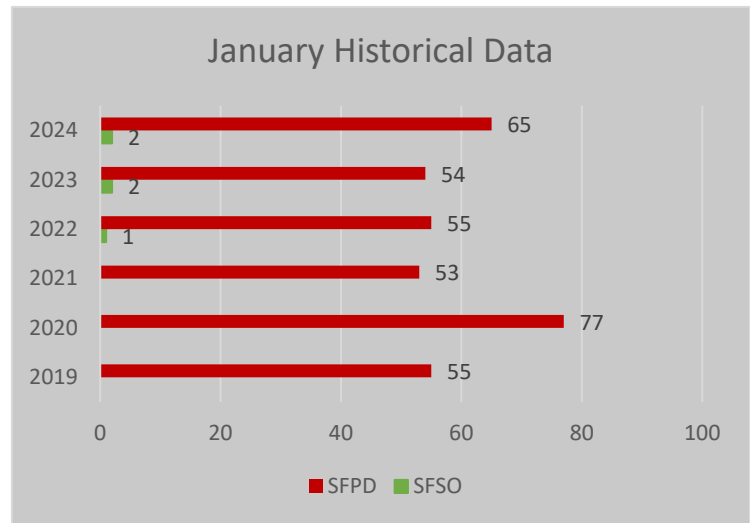

Summary of Complaints Received in January 2024

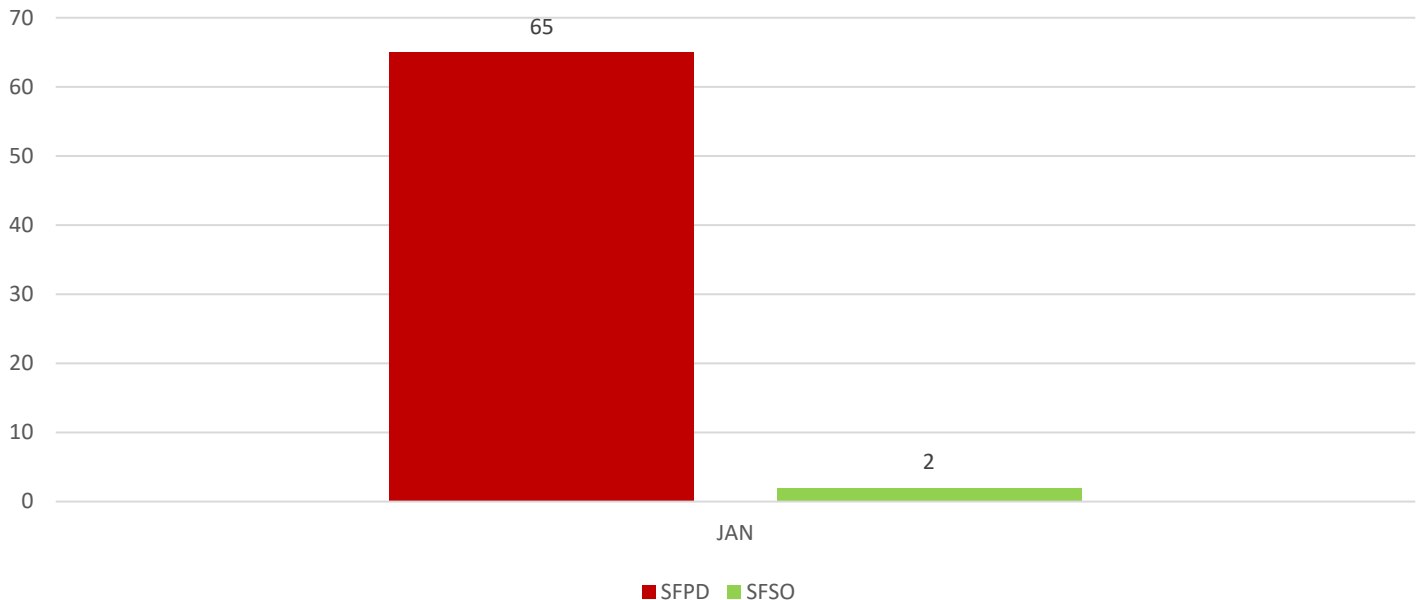
The Department of Police Accountability received a total of **67** cases in **January 2024**, **65** SFPD complaints and **2** SFSO complaints. Compared with a total of **56** cases, **54** SFPD complaints and **2** SFSO complaint, in the same period last year, the **January 2024** case total is **13%** higher than the five-year average and is **20%** higher than the previous year.

Currently, DPA has a total of **368** pending cases, **345** SFPD and **23** SFSO.

In January, DPA received a total of **1** referral(s) from SF Sheriff's Office and referred a total of **4** case(s) to SFSO.



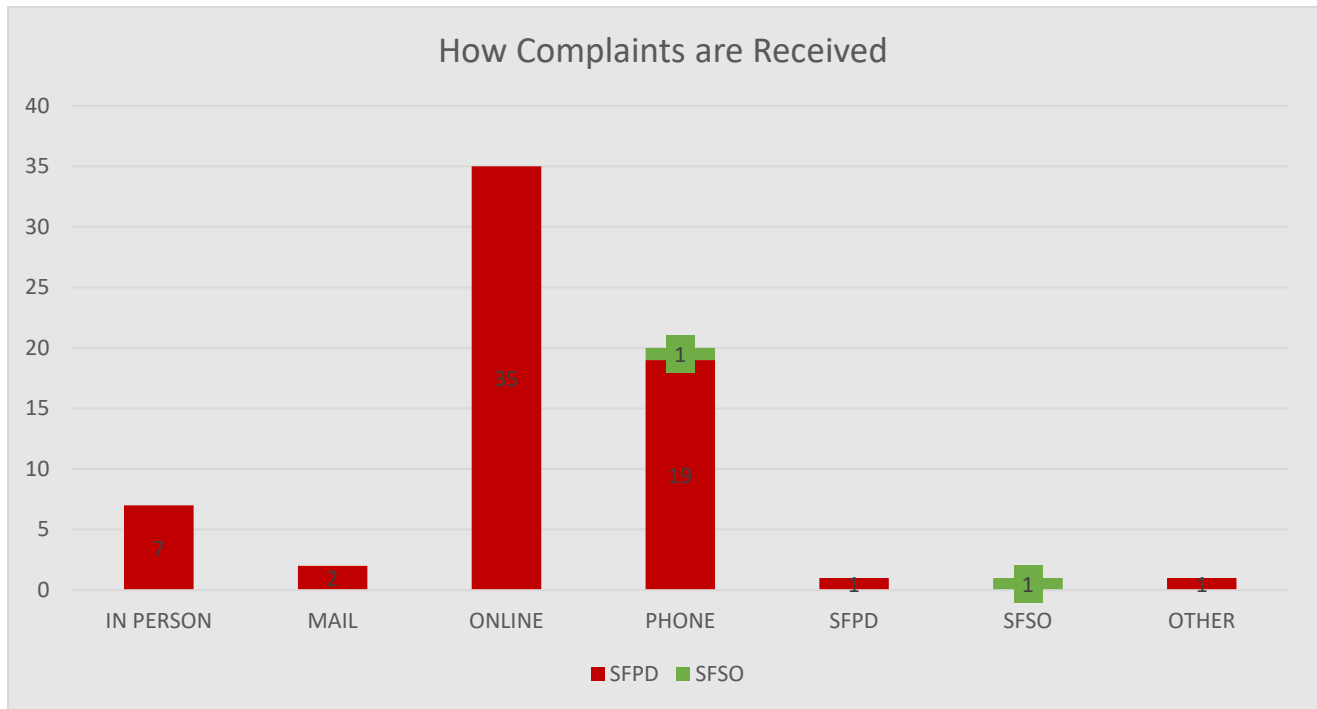
Year to Date Monthly Count of Cases Received (SFPD+SFSO)
