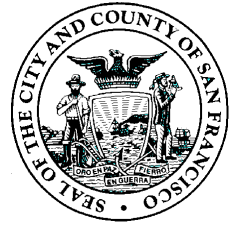

Ramaytush Ohlone Land Acknowledgement

The total proposed agreement amount is \$3,427,200 which includes a 12% contingency for the term of 09/01/2023 through 02/28/2025 (1 year and 18 months).**
