Department General Order (D.G.O.) 5.15: Enforcement of Immigration Laws, mandates that the SFPD provide a written report to the Police Commission annually.

The report per DGO 5.15 is to include the following:

- (1) a description of all communications received from the Federal agency charged with enforcement of the Federal immigration law, including but not limited to the number of civil immigration detainees, notification requests, or other types of communications; and
- (2) a description of any communications the Department made to the Federal agency charged with enforcement of the Federal immigration law, including but not limited to any Department's responses to inquires as described in subsection 5.15.07(1) of this DGO.

For the reporting period 01/01/23-12/31/23 the SFPD received seven (7) requests for incident reports from the Department of Homeland Security to aid them in Immigration Enforcement. All seven requests were denied in writing. Attached is the annual report for the period 01/01/23-12-31/23.
