

Firearm Discharge Review Board

In the 4th Quarter of 2023, the Firearm Discharge Review Board reviewed the following completed Officer-Involved Discharge.

- OIS 17-007
- OID 002-23

Officer-Involved Shooting 17-007

On December 1st, 2017 at approximately 1030 hours, Officers from Bayview Station responded to a report of a carjacking. The vehicle that was carjacked was reported to be a white lottery van.

SFPD units located the lottery van and began a vehicle pursuit. The Officer-Involved member was the front passenger of the primary pursuing unit.

At the time of the incident, the Officer-Involved member was on their fourth day of the Field Training Program and riding with their Field Training Officer who was the driver of the primary pursuit vehicle.

During the pursuit, the driver of the lottery van stopped quickly, exited the van, and ran toward the Officer-Involved member who was still seated inside the patrol vehicle.

Officer-Involved Shooting 17-007 (cont'd)

While seated inside the patrol vehicle, the Officer-Involved Member drew from their holster and fired one shot through the passenger window, striking the suspect.

The suspect was pronounced deceased.

During an interview, the Officer-Involved member stated, based on their training and due to the carjacking being a violent felony in which the suspect was running toward him, opposed to away from him, he believed that the suspect was attempting to ambush him.

Officer-Involved Discharge 002-23

On Wednesday, July 5th, 2023 at approximately 0430 hours, an SFPD Officer was off-duty and inside their residence in Santa Rosa, CA.

While inside their bedroom, the Officer attempted to unload their personally owned firearm, an HKP 2000 9mm handgun.

The Officer pressed the magazine release button when the firearm slipped from their hand.

The Officer attempted to grab the firearm.

The Officer accidentally pressed the trigger when they grabbed the grip of the firearm, which released one round from the barrel.

Officer-Involved Discharge 002-23 (cont'd)

The Officer observed that the bullet shot through the top portion of their bedroom window, creating a small hole. The bullet followed a trajectory in an unknown direction.

The Officer conducted a search for anyone who might have been shot and found that nobody was injured.

The Officer contacted the Sonoma County Sheriff's Office who declined to respond to the scene based on the fact nobody was injured.
