## Discussion:

The following report is offered in accordance with Section VII of the Protocol between the Department of Police Accountability and the San Francisco Police Department regarding responding to written requests for documents.

Routine requests for documents received at bureaus, divisions, units, stations, and details were not logged in formally at the Legal Division. However, copies of the requests received are kept in a monthly file.

During the 4<sup>th</sup> quarter of 2023, San Francisco experienced a unique challenge in hosting APEC (Asian Pacific Economic Cooperation conference) between 11/09-11/20/23. That event required all staff, including administrative, to be deployed outside of their normal assignments and hours with a focus on the event and public safety.

A review of the 44 late productions showed that DPA made 4 requests during the APEC event and 11 of the productions had due dates during the APEC event. I am aware that A/Capt. Wilhelm was in contact with DPA regarding investigatory interviews during this time frame. I do not know if a discussion was had regarding an overall extension for document production.

I recommend that the Legal Division and DPA have greater contact and understanding when faced with unique events, such as APEC, Major Chief's Conferences, etc... to allow for reasonable extensions in producing documents for routine or non-routine requests.
