LHH HUMAN RESOURCE SERVICES REPORT **Submitted to the Joint Conference Committee (February 2024)**

1) LHH vacancies were at 13.8% in January seeing an increase from the 12.7% in December.

We hired a total of twenty-five (25) employees between January 1 and January 31,2024, in various classifications and had four (4) separations during the same period including one (1) retirement.

We continue to prioritize and support with the hiring of the RN class. The vacancy rate currently stands at 7.69% for the month of January 2024 (16.5 vacancies). Of these positions, we are in the midst of processing five (5) reassignments. We have made candidate selections for 10 of the remaining positions and they will begin the onboarding process next week.

With regards to Nursing Managers (2322) class, we are currently in the process of hiring for 6 of the vacant positions. The new eligibility list is awaited for this classification to begin the hiring process.

There are currently 27 openings for the Licensed Vocational Nurses category or the 2312 class for which we have made selections for 19 positions. We have candidates being interviewed for 6 of the other vacancies while 2 of the vacancies are just beginning the hiring process.

With the Certified Nursing Assistant category (2303 CNAs), we are currently seeing a vacancy of 42 positions in this classification. Eighteen (18) of these positions are being processed for reassignment. Sixteen (16) of these vacancies are in the selection process (Interview process). Eight (8) of the remaining positions will begin the hiring process soon.

The HR team is also continuing to process vacancies within several classes through an efficient batch hiring process. Currently we are beginning to onboard 50 new hires in the 2903 (Hospital Eligibility Worker) classification, 7 in the 7334 (Stationary Engineers) classification, 15 of the 2593 (Health Program Coordinator) classification. We are also beginning the hiring process for 32 vacancies across DPH for the 2430 (Medical Evaluations Assistant) classification. The batch hiring process continues to identify efficiencies in improving the hiring process as we look at vacancies across DPH and ensure a better outcome for both the candidates and the hiring managers through this process.

The HR team regularly holds vacancy meetings with Exec leaders and hiring managers on a weekly, monthly basis to go over the vacancy information and hiring plans.




