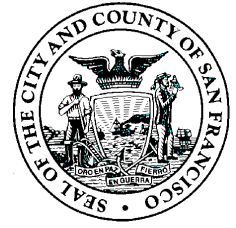

- Each individual may comment 1 time per agenda item.

- After you speak, you will go back to listening mode. You may stay on the line to provide public comment on another item.
