KNOW YOUR RIGHTS UNDER THE SUNSHINE ORDINANCE

Government's duty is to serve the public, reaching its decision in full view of the public. Subcommittees, boards, councils and other agencies of the City and County exist to conduct the people's business. This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review. LOBBYIST ORDINANCE

Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [SF Campaign & Governmental Conduct Code 2.100] to register and report lobbying activity. MEETING AND AGENDAS POLICIES

DJJ Subcommittee Meeting procedures do not permit:

- Persons in the audience to vocally express support or opposition to statements by the Subcommittee members or by other persons testifying;
- Ringing and use of cell phones, pagers and similar sound-producing electronic devices, (violators may be removed from the meeting room); and
- Signs to be brought into the meeting or displayed in the meeting room.
