- How close are you to hitting the start of year projections for how much the department will spend on storage or computing power?
- For the cost on the low scenario, which of the line items will and will not be part of the ask?
- Can you better explain the nomenclature? For example, public cloud versus commercial public cloud.
- Why is public cloud more affordable than government cloud, and what is the difference?
- Are there plans for centralization of specific activities across city departments?
