INTRODUCTION

a. Describe the business. What does it sell or provide?

A&W Contractors supplies and installs windows in the San Francisco Bay Area. The company can customize windows to fit individual styles, or have repairs made to existing windows. Their team of installers has years of experience in this industry and helps clients find the right windows that will last for years.

A&W Contractors offers a variety of window styles and colors that customers can customize to meet their needs. With a great selection of materials and colors, new windows and window treatments reflect different tastes and lifestyles:

- Aluminum windows are durable and maintenance-free, and they resist harsh weather.
- Vinyl windows are highly resistant to scratching or cracking.
- Wood windows are light but strong and serve as a good insulator.
- Skylights are a great way to add light to small spaces.
- Blinds and shades dress up any room in the home in a variety of styles, including wood blinds, vertical blinds, and more.

b. Describe whom the business serves.

A&W Contractors serves contractors and homeowners in the San Francisco Bay Area. The predominate customers are Chinese speaking or immigrants in the Sunset and Richmond districts of San Francisco looking for reasonably priced windows. These customers are also looking for a trustworthy company with a solid reputation.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Quality window installations and reliable window repairs.

a. Provide a short history of the business, including locations and owners.

A&W Contractors, Inc. was founded in 1983 at 1549 Noriega Street by Angela Chu and William Chu. They both immigrated to San Francisco in the 1960s where they met each other and

eventually got married. They opened the window business because their son at age 3 was in and out of hospitals, and Angela had difficulty working a 9-5 job. She needed a new line of work.

In 1988, William decided to leave the business, and Angela became sole owner of the business.

Today, A&W Contractors remains at the same exact location, and Angela Chu remains the owner.

A&W is known for reasonably priced windows, and Angela Chu is known as the "Window Lady." The business is the first Chinese speaking window company in the Sunset district and possibly the entirety of San Francisco. Angela also visits clients to provide in-home estimates and measurements, which is rare for a woman in the male dominated window profession.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1983 to 1988: Angela Chu; William Chu

1988 to Present: Angela Chu

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

A&W Contractors, Inc. has never ceased operations since it was founded in 1983, even during the COVID pandemic or when Angela was undergoing chemotherapy.

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

A&W Contractors, Inc is the first Chinese owned and Chinese speaking window store in San Francisco. It is a fixture in the Sunset neighborhood. Business is mostly made by word of mouth. Angela is well known throughout the neighborhood, and she supports local businesses in her area.

b. Is the business associated with significant people or events, either now or in the past?

During the COVID pandemic, the local Chinese bakery shut down. In Chinese culture, many folks head to the bakery to chat and socialize with their fellow neighbors before the start of their work day. With the COVID shutdown of the city and now the permanent shutdown of the bakery, local residents were craving to find a new place to socialize, to break free from the

mental health crisis during the pandemic. Familiar faces at the bakery started to stop by A&W and chat. They would share snacks. Angela bought a new coffee pot to brew coffee for her friends, and some would contribute bags of coffee. A&W was not only a window company, it became the social spot for some residents – somewhere where they could convene and have some semblance of pre-pandemic life.

c. How does the business demonstrate its commitment to the community?

A&W Contractors, Inc. provides reasonably priced windows to the community when prices have skyrocketed elsewhere. It also remained open during the COVID pandemic. The business welcomes local residents to come in to socialize.

d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

The business has not been referenced in the media, business trade publication, and/or historical documents.

e. Has the business ever received any awards, recognition, or political commendations?

A&W Contractors, Inc. has an A+ rating from the Better Business Bureau.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If A&W Contractors were to close, San Francisco would lose a Chinese speaking window supply and installation business. It would also lose a fixture in the Sunset district, a business that was built on honesty, low prices, and trust. It would lose the local spot where residents often convene to chat with Angela and other friends.




