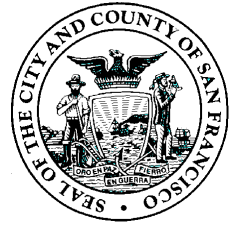

Ramaytush Ohlone Land Acknowledgement

The UCSF Embrace program will provide equitable, trauma-informed and culturally responsive prevention and mental health care to serve a population that has experienced disparities in care and health outcomes. The total proposed agreement amount is \$9,615,203 which includes a 12% contingency for the term of March 1, 2024 through June 30, 2029 (5 years and 3 months).**

- Each individual may comment 1 time per agenda item.

- When it is your time to speak, you will hear “Your line has been unmuted.”

- You are encouraged to state your name clearly. As soon as you speak, your time allotment will begin.
- After you speak, you will go back to listening mode. You may stay on the line to provide public comment on another item.
