# 5. Surveillance Technology Policy - Juvenile Probation Department - Web Content Filtering Technology - Web Filtering Software - (Action Item)

Elisa Baeza and Bobby Wong presented on behalf of the Juvenile Probation Department on their Web Filtering Technology.

Committee members asked the following questions:

- Is the filtering technology uniformly applied to all residents, or is there a difference based on age group?
- Are users notified in advance that surveillance technology is on the computer?
- Are individuals associated with a surveillance file? If not, how will the web content data correlate back to said individual if there is no unique identifier?
- Can the department elaborate on the utility of retaining web content data for a year, and what would be the downside of not retaining the data at all?

Committee members made the following suggestion:

 Revise language to eliminate double negatives on Page 5 of the Surveillance Technology Policy

# 6. Surveillance Technology Policy - Municipal Transportation Agency - Camera, Non-Security - Automated Speed Enforcement Camera - (Action Item)

Sohail Warsi and Robert Miller presented on behalf of the Municipal Transportation Agency on their Automated Speed Enforcement Camera.

Committee members asked the following questions:

- Who makes the determination on which neighborhoods the cameras are placed?
- What are the plans to notify drivers of the areas where cameras will be placed?
- At what speed will the camera be triggered?
- Is there a reason why cloud storage has been omitted, and is there an advantage to having it as only local storage?

Chris Ward Kline is in support of the cameras, and expressed concerns about the intersection at Van Ness Ave and McAllister Street.
