#### \* PUBLIC COMMENT INFORMATION

Members of the public may address the JJCC Council for up to three (3) minutes on any matter within the JJCC's jurisdiction. The Council will hear public comment on all agenda items before, or during discussion of, the item. The Council will also hear public comments on items not listed (see Agenda, Item 3).

The period of time allowed for public comment may be modified by the Chair in the interest of fairness to all those wishing to address the Council. Speakers shall address their remarks to the Council as a whole and not to individual members or Department personnel. The lack of a response by the members or department personnel does not necessarily constitute agreement with, or support of, statements made during public comment.

Public comment may be made:

- 1) In person at the meeting.
- 2) By email to sheryl.cowan@sfgov.org if received no later than 5:00pm the day before the meeting.
- 3) By leaving voicemail at 415-753-7556. Comments submitted no later than 5:00pm the day before the meeting will be read into the record during the meeting and will be treated as a substitute to providing public comment during the meeting.

NOTE: Persons who submit by written public comment or by voice mail in advance on an agenda item **will not be permitted to also provide public comment on the same agenda item(s) in-person during the mtg.** 

#### **DISABILITY ACCESS & ACCOMMODATION**

#### KNOW YOUR RIGHTS UNDER THE SUNSHINE ORDINANCE

Government's duty is to serve the public, reaching its decision in full view of the public. Commissions, boards, councils and other agencies of the City and County exist to conduct the people's business. This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review. Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [SF Campaign & Governmental Conduct Code 2.100] to register and report lobbying activity. **MEETING AND AGENDAS POLICIES** Citizens are encouraged to testify in person at JJCC Meetings and/or write letters to the JJJC: c/o Juvenile Probation Department, 375 Woodside Avenue, Room 243, San Francisco, CA 94127.

JJCC procedures do not permit:

- Persons in the audience to vocally express support or opposition to statements by members or by other persons testifying;
- Ringing and use of cell phones, pagers and similar sound-producing electronic devices, (Violators may be removed from the meeting room); and
- Signs to be brought into the meeting or displayed in the meeting room.
