Avant Bruce Bio: My interest in my craft began after learning a intro of bladesmithing in boy scouts and camping. I gained a passion for blacksmithing in high school shop class making metalwork projects. In 2021, I started my own workshop and myself creations that obtained the attention of fellow enthusiast. It motivated me to make an official business for it cause of the traditionalism of Blacksmithing becoming a dying art. My work is made and catered towards hobbyist who enjoy fishing, camping, hunter-gathering, blacksmithing, and welding.

1. Describe your work in detail. How do you make it?

My work is made from project blank blades, designer custom handles ranging from bare wood, kirnite, water resistant wrap, and animal bone. My other styles include kit camping blades that also require some construction and anvil made knives created in forge fire. Proper measurement is a must especially for anvil made blades to ensure its highest capability of long lasting.

2. Where did you learn your craft?

Self taught myself with designing my own hand crafted creations. As well as engraving the fundamentals & basic knowledge of bladesmithing from research, online courses, and book study.

I taught myself how to do my own craft, but now attend blacksmithing classes to further perfect my art creations.

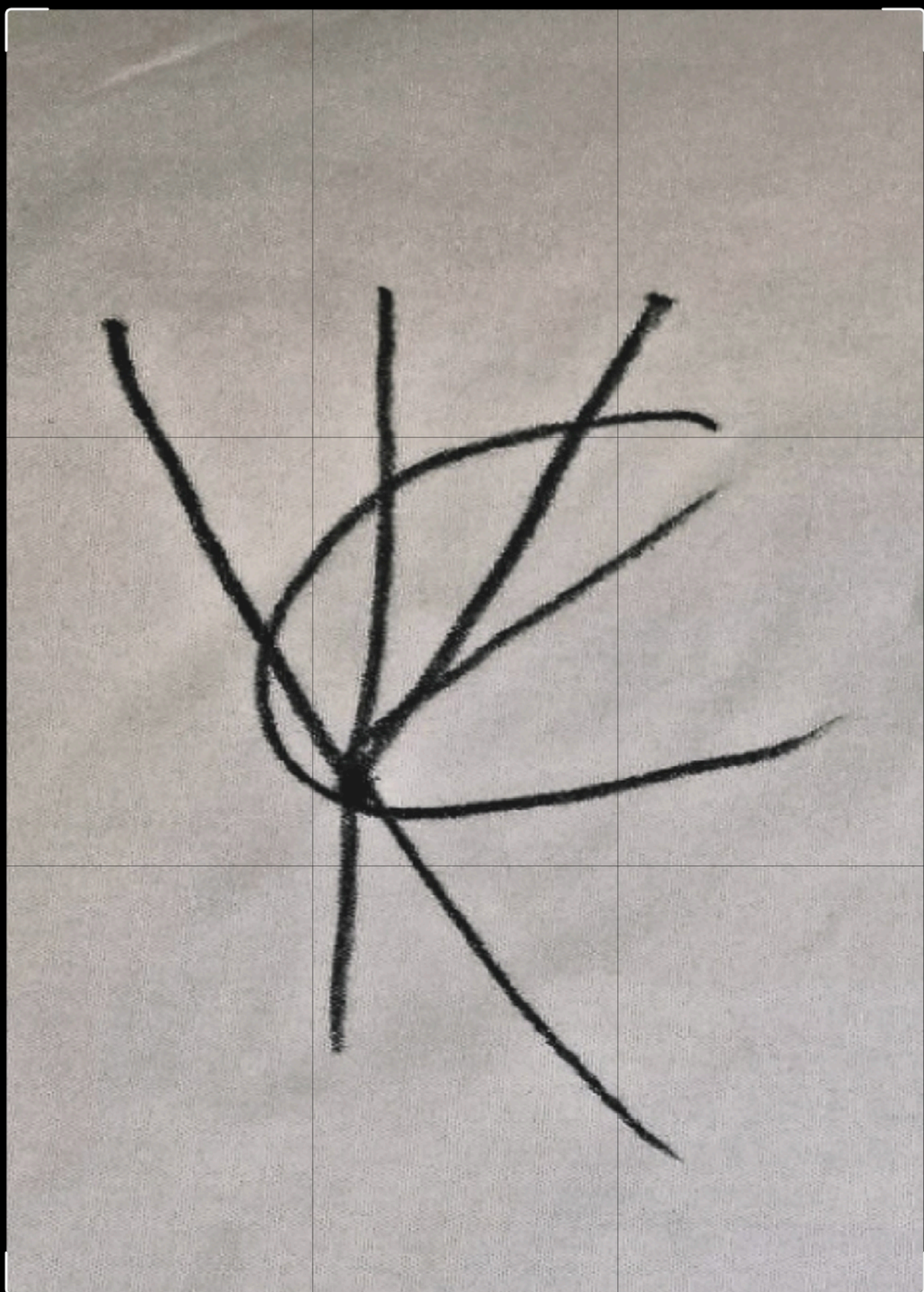
