Appealing the ISSUANCE on February 6, 2024, to Electric City, of a Notification of Tobacco Permit Denial (DENIAL of Retail Tobacco Sales Permit for the following reasons: (1) Pursuant to San Francisco Health Code (SFHC) 19H.4(f)(3), no new permit shall be issued if the Applicant will be within 500 feet of a School; the Establishment is located within 500 feet of one School; (2) Pursuant to SFHC 19H.4(f)(4), no new permit shall be issued if the Applicant will be located within 500 feet of an existing Establishment; the Applicant's Establishment is located within 500 feet of four other Establishments that have valid SFDPH Retail Tobacco Sales Permits; and (3) Pursuant to SFHC 19H.4(f)(5) and 19H.5(a), no new permit shall be issued in any Supervisorial District that has 45 or more Establishments with SFDPH Tobacco Sales Permits: Establishment is in Supervisorial District 3 which currently has 95 valid SFDPH Retail Tobacco Sales Permits).

PERMIT NO. EHD ID NO. 97731. FOR HEARING TODAY.

ACTION: Upon motion by Commissioner Swig, the Board voted 5-0 to deny the appeal and uphold the determination denying the Retail Tobacco Sales Permit, on the basis it was properly issued as the applicant did not qualify for a permit under the Health Code.

ACTION: Upon motion by Commissioner Swig, the Board voted 5-0 to grant the appeal and issue the permit on the condition it be revised to require the removal of the windows and skylight at the southwest corner of the fourth floor of the building as identified on the schematic submitted at the

hearing. This motion was made on the basis that the permit was properly issued, but the permit holder was making a benevolent accommodation to the appellant.

PUBLIC COMMENT: Georgia Schuttish spoke about the importance of demolition calculations on building projects. She noted that this project did not include demolition calculations on the plans submitted for the hearing or on the plans in PIM.

Dana Atherton, the neighbor adjacent to the subject property, noted that there was no abatement for lead or asbestos during the tear down phase of the project. He also stated that his concerns about privacy were disregarded.
