President Collins asked for any agenda changes and no changes were suggested.

President Collins announced the public meeting instructions.

Commission Secretary Dhaliwal announced public comment instructions.

President Collins began the meeting by reading the Arts Commission's land acknowledgment statement.

2. Approval of the Minutes (6:31)

Commissioner Beltran, seconded by Commissioner Stryker moved to approve the January 5, 2024, minutes.

There was no public comment.

3. General Public Comment (7:52)

There was no public comment.

4. Director's Report (8:50)



Director Remington shared he was the keynote speaker for San Francisco African American Historical and Cultural Society's 2024 Black History Month Kick-Off Program at City Hall. He noted San Francisco invested over \$18.4M in support of Black artists, arts organizations, and cultural centers. He mentioned a Meet the Arts Commissioners social media campaign started last month and will highlight 1 to 2 commissioners each month throughout 2024. He spoke on his attendance of an artist reception at the Main Library for *we were here*, an exhibition by 2022 Artist in Residence tanea lunsford lynx. He shared the exhibition will be on view through March 1 at the African American Center located on the 3rd floor of the San Francisco Public Library Main Branch. He mentioned that on January 12 he participated in in a press conference held in Chinatown where the location of the new Chinese Cultural Center at 667 Grant Avenue was announced.

Director Remington provided Community Investments updates. He shared the San Francisco Arts Commission (SFAC), and Grants for the Arts (GFTA) are evaluating the first five years of the Arts Impact Endowment Investments. He mentioned that staff are preparing for community outreach for Cultural Services Allocation Plan (CSAP) evaluation by hosting a series of open houses and launching a public survey. He noted the open houses will be held at Mission Cultural Center for Latino Arts in-person on February 28, at the Southeast Community Center and at City College Chinatown/North Beach campus in-person on February 29, and will host a virtual open house on March 1. He added a youth focus group will also be held in-person at Youth Exchange on February 28. He noted the public survey will be available both digitally and in paper format and will be available in English, Spanish, Filipino, and Chinese. He included the public survey will be launched on February 12 and open through March 11.

Director Remington continued with Gallery updates. He shared on January 25, the Galleries team held an opening reception at the Main Gallery for "Conversation 8: Harry Doge and Alicia McCarthy", curated by Nancy Lim. He noted that the exhibition will be on view through April 27. He announced that the Gallery team launched a Mentorship and Exhibition Fellowship opportunity for emerging artists detailing that two artists will be selected to engage with a curator/mentor over the course of ten months,



culminating in a two-person exhibition opening in the Fall of 2024 in the SFAC Main Gallery. He noted the application deadline for the Request for Qualifications opportunity is February 20, by 11:59 p.m.

Director Remington moved onto Public Art updates reminding all about Public Art Request for Proposals (RFPs) and Request for Qualifications (RFQs) approaching deadlines: *Outdoor Exhibition of Existing Large-Scale Sculptures for Display in Particia's Green* applications for RFP has been extended to March 1, 2024, *Treasure Island – Water Resource Recovery Facility* applications for RFQ due March 11, 2024, *Treasure Island – Cityside Park* applications for RFP are due March 15, and *Mission Bay School Public Art Project* applications for RFQ are due March 18.

There was no public comment.

5. Committee Reports and Committee Matters (21:00)

1. Visual Arts Committee (21:17)

Commissioner Suzie Ferras provided an overview on two new Public Art project opportunities. She shared San Francisco Public Utilities Commission's Treasure Island Water Resource Recovery Facility has an art opportunity located on the concrete facades of the Maintenance and Administration Buildings. She continued to explain the façade mounted artwork will consist of imagery on up to 2850 square feet of precast concrete panels. She noted the artwork budget is \$610,000 and the RFQ is currently posted on the SFAC website and closes on March 11th. She mentioned a second upcoming public art opportunity at the San Francisco Unified School District to build a new Mission Bay School, scheduled to open August 2025 for the 2025-2026 academic year. She noted the artwork budget is \$136,000 and the RFQ is currently posted on the SFAC website and will close on March 18th.

2. Executive Committee (24:42)

1. Executive Committee Report (24:50)

President Chuck Collins provided a brief update on the Executive Committee. He shared that Director Remington provided his report to the committee. He mentioned the budget was discussed and noted that a presentation will be given shortly on this.

2. Arts Commission FY 2024-2025 and 2025-2026 Draft Budget. *(26:02)*

Deputy Director of Administration and Finance Sarah Hollenbeck provided a comprehensive overview of the budget process and timeline. She discussed the budget instructions from the mayor, the current budget environment, and various aspects related to revenues, expenditures, capital, and budget priorities.

Deputy Director Hollenbeck emphasized that the mayor's instruction was to target a 10% cut in general fund support for both FY25 and FY26. She added that departments were asked to identify an additional 5% contingency in case the forecast softens while the mayor's budget is being finalized.

She described the agency's revenue streams. She highlighted the hotel tax fund, which is expected to grow in the upcoming years. She also presented an overview of the operating and capital budget as well as the agency's budget priorities.

Commissioners had questions on the budget that were answered by Director Remington, Deputy Director Hollenbeck, and President Collins.

Commissioner Beltran, seconded by Commissioner Schnair move to approve proposed Fiscal Year 2024-2025 and 2025 –2026 Arts Commission budget.



There was no public comment.
